BLM policy is to establish Appropriate Management Levels (AML) as a range with upper and lower levels, the numbers displayed represents the upper limit.

Acres have been calculated using current digitized (GIS) maps using the UTM (Universal Transverse Mercator) projections.

Acreage transferred from BLM to another agency are not deducted from the HA acreage.

HA acreage totals are calculated based on designations made in the early 1970's.
