Notes on Current Status	<p>Due to the partial Government Shutdown, the Public hearing had to be canceled. A corrected FRN was published on May 10, 2018 for availability of EA for public comment again, as well as notice of public hearing to discuss the EA, proposed lease sale, FMV and MER. The BLM accepted any comments submitted during the originally posted comment period in addition to any others that came in during the new comment period. Public Hearing Transcript being prepared by court recorder. Comment period closed June 10, 2019. BLM is reviewing and incorporating comments into EA at this stage before a DR is issued. The applicant requested partial withdrawal of acres in its application on June 27, 2019. The BLM received corrections to the requested legal description from the applicant in October, 2020. The BLM is currently performing a cadastral review on the updated legal description. The BLM is also awaiting information from the applicant/contractor in order to complete NEPA. (ePlanning page link) The applicant requested that continued processing of the application, including NEPA, be put on hold until February, 2021.</p>
