EL MALPAIS NATIONAL CONSERVATION AREA (NCA) OFFERS:

- Unique geological history
- Extensive cultural history
- Inspiring natural resources
- 2 designated Wilderness areas
- 3 Wilderness Study Areas
- Designated trails including Continental Divide National Scenic Trail
- Breathtaking scenic resources



CURRENT NCA VISITATION & FEE STRUCTURE

- El Malpais NCA Visitation yearly average – 264,764
- The NCA is open year-round
 - Ranger Station normal operating hours are Thursday – Monday from 8:30 AM to 4:30 PM
- Currently every area is Fee Free
- Average of 4 Special Recreation Permits issued each year primarily Commercial Outfitting and Guiding Permits







RECREATION SITES IN EL MALPAIS NCA WHICH QUALIFY AS A FEE SITE

Sites which qualify as a **Standard Amenity Fee Site**:

- El Malpais Ranger Station Recreation Site
- La Ventana Natural Arch Recreation Area
- South Narrows Picnic Area

Site which qualifies as an **Expanded Amenity Fee Site**:

Joe Skeen Campground



WHAT MAKES A SITE ELIGIBLE TO BECOME A STANDARD AMENITY FEE SITE?

A site must include these six amenities for it to qualify as a standard fee site:

- ☑ Developed Parking
- ☑ Permanent Toilet Facility
- ☑ Permanent trash receptacle
- ☑ Interpretive signing
- Picnic Tables
- ☑ Security services

All amenity requirements are met by each of these three recreation areas within El Malpais NCA.

WHAT MAKES A SITE ELIGIBLE TO BECOME AN EXPANDED AMENITY FEE SITE?

A site must offer 5 of 9 amenities for it to qualify as an expanded amenity fee site:

- ☑ Tent or Trailer Spaces
- ☑ Picnic Tables
- Access Roads
- ☑ Reasonable Visitor Protection
- ☑ Permanent Toilet Facility
- ☑ Permanent trash receptacle
- ☑ Simple Devices for Containing Campfires
- ⊗ Drinking Water
- \otimes $% \ensuremath{\mathsf{Fee}}$ Fee Collection by an Employee or Agent

Joe Skeen Campground in El Malpais NCA offers 7 amenities.



JOE SKEEN CAMPGROUND AMENITIES:

- Graveled route to and through campground
- 2 vault toilets
- 10 campsites with picnic tables and shelters
- 1 camp host site with picnic tables and shelter
- Grills and fire rings at each campsite
- 3 bear proof trash receptacles
- Welcome kiosk with regulations
- Ample parking for vehicles pulling trailers up to 50 ft.





JOE SKEEN CAMPGROUND VISITATION AND FEE STRUCTURE

- No concrete visitation data
- Observation from park rangers is that campground use is steady throughout the year, with slight decrease in use during the coldest winter months of January and February.
- Currently, the campground is a fee-free area



PROJECTED ANNUAL EXPENDITURES FOR JOE SKEEN CAMPGROUND (FY 2021 - FY 2025)

| Operating Expenses | Minimum | Maximum |

| Volunteer campground host reimbursement (6 months, \$38/day) | \$6,916.00 | \$6,916.00 |

Minimum range are FY 2021 projected costs. Maximum range determined by including a 2% increase in labor and larger operational costs for each fiscal year, accounting for the general effects of inflation. Camp host reimbursement is a fixed cost and is not adjusted for inflation.



EL MALPAIS NCA PROPOSED FEE MODIFICATION

Rio Puerco Field Office proposes to:

 Implement an expanded amenity fee at Joe Skeen Campground for \$5.00 per night per campsite for up to two vehicles and \$5.00 per night for additional vehicles

Campground would remain firstcome, first-served area for now.

2. Currently maintain El Malpais Ranger Station Recreation Site, La Ventana Natural Arch Recreation Area, and South Narrows Picnic Area as fee-free sites.








| Fiscal Year | Estimated Group Size | Projected User Nights | Estimated Revenue Range (assuming fee increase) | Estimated Revenues (with no fee increase, ex. donation only) | Total Annual Revenue |

| 2022 | 4 - 8 people | 2 nights | \$9,125 - \$12,775. | \$1,560 | \$10,685 - \$14,335 |

This estimated projection of revenues (assuming fee increase) is based on a range of 50% - 70% capacity at the campground throughout the year, meaning 5 – 7 sites would be filled every day of the year.




IMPACTS FROM IMPLEMENTING A FEE AT JOE SKEEN CAMPGROUND

- Additional revenue for labor and operational needs
- Increased BLM presence to halt resource damage
- Ability to improve campground facilities, recreational opportunities, quality of the experience, and visitor satisfaction
- Ability to sustain and direct management of the recreation fee site.
- Ability to continue operations despite potential increase of costs of goods, labor, and/or services.
- Return visitors may find it off-putting that they are now required to pay a fee.
- Socio-economic impacts to low-income or minority populations are unknown presently, but impacts could be expected with any fee. Collection of RUPs will be used to understand visitor demographics.







IMPACTS FROM <u>NOT</u> IMPLEMENTING A FEE AT JOE SKEEN CAMPGROUND

- Loss of potential revenue in L1232 funds to augment funds for labor and operational costs.
- Potential environmental degradation of resources in and around the campground.
- Potential degradation of recreation experience and public satisfaction for current and new visitors.
- Costs of goods, labor, and services increase at a faster rate than fee revenue projections.
- Socio-economic impacts to low-income or minority populations would be favorable because no fee would be required.



JOE SKEEN CAMPGROUND SHORT-AND LONG-TERM FUTURE EXPENDITURES

- Barricades (boulders) at Joe Skeen
 Campground to prevent user-created routes/camping areas (\$7,500)
- Stabilize general site erosion at Joe Skeen Campground (\$5,000)
- Repaint picnic shelters and vault toilet flooring at Joe Skeen Campground (\$5,000)
- Replace fire rings at Joe Skeen with maintenance-friendly versions (\$8,000)
- Add additional concrete sidewalks at Joe Skeen Campground to improve ADA accessibility (\$25,000)
- Revamp campground host area and reclaim user-created turn-around (\$75,000)
- Deferred Maintenance: New potable waterline system and new electrical system for Joe Skeen Campground (\$447,000)
