KFO Site Improvements



Scouts refurbish benches at Burro Creek Campground

In FY21, the Kingman Field Office (KFO) partnered with Scouts to complete site improvement projects at the Burro Creek, Wild Cow Springs, and Windy Point Campgrounds. The Scouts trimmed vegetation near a fence line along a riparian area, refurbished benches, and removed graffiti at the Burro Creek. Scouts maintained site trails and fixed tent pads at individual sites at Wild Cow Springs. Scouts installed a new kiosk and site posts at Windy Point. Amount expended: \$13,456.25

KFO Non-motorized Trail Maintenance

In FY21, KFO partnered with the Colorado River Area Trail Alliance (CRATA) to complete trail maintenance in the Cerbat Foothills Recreation Area (CFRA) in preparation for a permitted mountain bike race that CRATA hosts annually. A total of 1.2 miles of non-motorized trail was maintained and included trimming brush, fixing tread, and building rock walls. Fee monies supported these projects through furnishing supplies, including gloves, tools, and other hardware. Amount expended: \$1,052.82.

Recreation Fee Dollars

Recreation Fee Dollars support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation
- Direct operating or capital costs associated with the recreation fee program

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.



Other Accomplishments

- Funded a host at the Burro Creek Campground to provide public information and facilitate fee compliance
- Funded a janitorial contract for the Burro Creek Campground
- Installed new site posts at the Burro Creek Campground
- Funded a fuels reduction project at the Wild Cow Campground
- Funds aided in a deferred maintenance project for the renovation of two restroom facilities at the Burro Creek Campground
- Utilized youth corps to construct a non-motorized interpretive trail around the Burro Creek Campground •Completed site road maintenance in the Burro Creek and Wild Cow Springs Campgrounds

- Funding will aid in the replacement of the potable water and sewer lines at the Burro Creek Campground that is being primarily funded out of the Great American Outdoors Act monies
- Fund a host at the Burro Creek Campground
- Fund a janitorial contract for the Burro Creek Campground
- Fund operations and maintenance of three fee sites
- The KFO plans to maintain two miles of non-motorized trails and three miles of motorized trails
- Continue to partner with external organizations to facilitate projects at recreation fee sites

Connecting with Communities

Since 2013, the KFO has proactively partnered with the Colorado River Area Trail Alliance (CRATA), a local chapter of the International Mountain Biking Association. The partnership between the CRATA and BLM has increased user engagement in non-motorized trails, facilitated the development of 8 miles of new non-motorized trails, reduced deferred maintenance of facilities and non-motorized trails, increased grant funding from Arizona State Parks and Trails, and enhanced opportunities for the CRATA to host annual mountain bike races bringing in new users facilitating economic growth in the local community because of recreational use on public lands.

Although most of these efforts have been focused within the Cerbat Foothills Recreation Area (CFRA), an 11,300-acre Special Recreation Management Area cooperatively managed by the BLM and the City of Kingman, the partnership has enhanced the KFO's ability to reach a broader group of users creating an opportunity for the BLM to better serve the needs in a community where interest in recreational pursuits continues to grow. This partnership has enabled the KFO to be more proactive in managing the public lands while also helping to promote stewardship and shared use of the public lands. Looking forward, the KFO will continue to partner with the CRATA organization and be engaged explicitly in creating non-motorized trails that are more accessible to families and trails that are easier for novice users to utilize to increase participation from a wider group of users than have previously been exposed to non-motorized recreational pursuits.
