Recreational Activities Abound

The Public Lands within the Ridgecrest Field Office serve as the backdrop for between 30 and 40 Special Recreation Permits annually. These SRPs encompass a variety of recreational activities such as Equestrian Endurance Rides, Marathon and Ultra Marathon running events, Four Wheel Drive and Dual Sport MotorcycleTours, Vending, Mountain Bike, Motorcycle, Truck, and Utility Terrain Vehicle(UTV) races. SRPs are the largest source of funds collected for the RecreationFee Revenue program.

Improving Recreation Experiences



Fossil Falls Campground Accessible Vault Toilet

Recreation Fee Revenue funds improved and maintained the visitors' recreational experience of the public lands. These efforts included cleaning and supporting 14 different vault toilet facilities throughout the field office. Recreation Fee dollars were partially used to fund a contracted Recreational Trail Maintenance Team. The team installed or maintained 2634 route markers along designated routes and maintained and stocked the 99 information kiosks within the Field Office.

Recreation Fee Dollars

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreationDirect operating or capital costs associated with the recreation fee program

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.



Other Accomplishments

The overall cost of the Vault Toilet Cleaning Contract was \$37,620, with \$6,048 of Recreation Fee dollars contributed towards this effort.

The overall cost of the Recreational Trail Maintenance Team was \$120,000, with \$36,000 of Recreation Fee dollars contributed towards this effort. With an additional \$825.19 worth of supplies purchased to support these efforts.

Campsite at Fossil Falls Campground

Partial fund the ongoing contract to clean and maintain 14 vault toilet facilities.

Labor costs are directly related to the processing, administration, and monitoring the Field Office's Special Recreation Permit program.

Perform campsite maintenance at the Fossil Falls Campground.

FY2026 - Install additional vault toilets within the Spangler Hills OHV Recreation Area. Recreation Fee funds will help leverage additional grant funds to accomplish this task. Funding carry-over will be needed and set aside for this project. Estimated Recreation Fee Funds Needed \$100,000 of an approximately \$250,000 project.
