The Jarbidge River Launch Site provides river access for whitewater boaters and anglers. The site includes boat ramps, picnic table, fire rings, and a vault restroom. There is also a foot trail that runs along the river's edge for approximately one mile and goes up out of the canyon. River users are required to fill out the free, self-registration permits located at the kiosk.

## **Recreation Fee Dollars**

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value. They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreationDirect operating or capital costs associated with the recreation fee program

## **Connecting with Communities**

The Jarbidge Field Office has been working with Twin Falls County on the development of some mountain bike trails in the area. The proposed project currently consists of approximately 26 miles of novice to advanced mountain bike trails on BLM-managed lands. The trails are conceptually designed and will go through public scoping and environmental analysis soon. This partnership with Twin Falls County addresses increased pressure from the public for more recreational opportunities in the local area. The project would provide some relief to surrounding areas that already receive heavy public use. Because the proposed trail and trailhead are completely on BLM-managed lands, Twin Falls County would contribute to the project via planning and maintenance support, including hosting public meetings, trail maintenance, and noxious weed control. Interpretive signing, particularly along the portion of the trail that parallels Salmon Falls Canyon, would provide users with information about the natural and cultural features and history of the area.
