## Datil Well Campground



Host site septic upgrade
The Bureau of Land Management upgraded the system and installed a 1,270-gallon septic tank with a drain line to reduce the amount of time it would need to be pumped annually, decreasing the overall cost. In addition, the staff upgraded the host site with new cold weather water connections and a 30/50-amp electrical pedestals. The site needed an upgrade to accommodate the current requirements for RV s.

## Datil Well Boundary Fence



SMRA boundary fence replacement
Staff rebuilt the Special Recreation Management (SMRA) fence to keep cattle from entering the campground from an adjacent Forest Service allotment. The fence was replaced using metal teepost and smooth wire to wildlife-friendly specifications to allow wildlife such as elk and deer to cross-Local staff estimated the cost of the fence and labor to build the fence to be 10,000 dollars.

## Recreation Fee Dollars

They support and enhance:

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as $100 \%$ of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation
- Direct operating or capital costs associated with the recreation fee


## Other Accomplishments

The BLM uses the generated fees to maintain the campground operation - the purchasing of supplies such as trash bags, hand sanitizer, safety equipment, signs, and toilet paper. The fees are used for reimbursement and used to maintain the Utility Terrain Vehicle used for cleaning and hauling garbage within the campground. Volunteers are integral to the campground operation to ensure compliance from visitors and provide interpretive information.
