# 5th Grade Poster Contest!



BLM staff presents Leave No Trace lessons

In partnership with Pacific Northwest Four Wheel Drive Association, BLM hosted a poster contest to promote Leave No Trace and responsible recreation ethics for all 5th-grade students in Lake County. Staff gave presentations in classrooms and followed by remote submissions of hand-drawn posters. The winning submissions were posted throughout the field office on kiosks to encourage responsible recreation for all users.

Recreation staff installed two new benches at Crack-in-the-Ground, one of the field office's most popular recreation sites. The benches provide restful areas in the shade for visitors at the beginning/end of the trail and the most popular turnaround point. These benches also allow physically limited users to break their journey into shorter sections while enjoying one of Lakeview Field Office's most unique recreation sites.

# **Recreation Fee Dollars**

They support and enhance:

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation
- Direct operating or capital costs associated with the recreation fee program

# Other Accomplishments

- Recreation staff installed a new kiosk at the Hart's Bar Day Use Area at the Warner Wetlands.
- Installed designated route signage throughout the Warner Wetlands Area of Critical Environmental Concern (ACEC) to ensure consistent on-the-ground information with updated ACEC brochures, maps, and kiosks.
- BLM hosted a successful volunteer workday at Christmas Valley Sand Dunes with the Pacific Northwest Four Wheel Drive Association.
