



# **El Malpais** National Conservation Area

## Accomplishments


In 2017, Rio Puerco Field Office (Field Office) began revitalizing the interpretation exhibit within the main atrium at the El Malpais National Conservation Area (Conservation Area). The upgraded exhibits have interactive features and 3D displays. The installation of this exhibit was completed in July 2021. A remodel of the Ranger Station was also completed in April 2021 which included repairing exterior mortar and stucco; restoring exterior wood features (vigas, latillas, log columns and lintel, canopy, and fence); repainting interior and exterior; refurbishing restroom flooring, plumbing fixtures, and counters; new kitchenette cabinets and sink; new flooring; mechanical room plumbing; update HVAC; and new track lighting in atrium. To provide a safe visitor experience, a Risk Assessment was completed at the Ranger Station in mid-July 2021. General preparations were completed throughout FY21 in order to ready the Ranger Station for public reopening on March 18, 2022.



El Malpais Ranger Station Exhibit and Remodel Complete July 2021


New interpretation materials for the NCA were produced and brochures updated throughout FY21. A Junior Ranger booklet for the El Malpais NCA was finalized and printed in December 2020. A Junior Ranger badge was also created and produced in FY21. An El Malpais Visitor Guide was created in collaboration with the Public Lands Interpretive Association and BLM which was finalized in December 2021 and will be

printed in FY2022. Interpretive panels meant to educate visitors about resources along the Ranger Station Nature Trail and about vegetation within the Ranger Station Courtyard were developed and printed in FY21. These projects were primarily funded through the BLM New Mexico State Office with National Conservation Lands funds.

To provide more accurate visitation counts, TRAFx traffic counters were installed at La Ventana Natural Arch Recreation Area, Joe Skeen Campground, and the South Narrows Picnic Area. There are plans in FY22 to install more TRAFx counters in other areas throughout the NCA.

Throughout FY21, El Malpais park rangers adapted to less in-person ranger-led activities by creating and posting on social media a series of videos about Leave No Trace Principles and a series of videos on El Malpais NCA resources. In June 2021, Rio Puerco Field Office released the El Malpais National Conservation Area Draft Business Plan for public review and comment. The objective of the El Malpais NCA Draft Business Plan is to provide the public with information on the current state of the recreation program; ensure consistency with required statutes and laws; establish future management goals and priorities of the program; and invite the public to submit comments on the proposed fee structure. The draft business plan establishes the Joe Skeen Campground as a fee site. The Business Plan proposes a fee of \$5 per night per campsite, for up to two cars, and \$5 per night for additional vehicles. In August 2021, a video field trip was prepared to present to the Northern New Mexico Resource Advisory Council in lieu of an in-person field day. The El Malpais NCA Draft Business Plan and the video was presented to and approved by the Resource Advisory Council on August 19, 2021.

An Ancestral Lands Conservation Corps trail crew completed trail maintenance along the La Ventana Natural Arch trail the week of August 24, 2021, through August 31, 2021. Rio Puerco Field Office and the National Park Service hosted a National Public Lands Day event at La Ventana Natural Arch Recreation Area on September 24. Along with Federal employees, 14 volunteers dedicated their time to remove graffiti from the sandstone beneath La Ventana Arch and assisted in re-graveling a portion of the trail.

### Challenges

As all units have experienced change in visitation throughout the COVID-19 pandemic, El Malpais staff have had to adapt their on-the-ground visitor interactions and facility maintenance techniques. To protect resources and prevent their degradation, field staff is needed on the ground with the increased of visitation. Off-road driving and user-made campsites are increasing within the Wilderness Areas in the Conservation Area. Law Enforcement, with field office staff, are working together to install carsonite signs and inform the public of the special restrictions. Staff are also engaging in stewardship outreach to public visiting the Conservation Area. A priority in FY22 is to fill a supervisory park ranger position to assist with El Malpais' day-to-day operations. Interpretive programs have been minimized throughout the past two years due to COVID-19 and FY22 allows opportunity to create more in-person ranger-led visitor experiences.

#### Visitors

Despite closure through FY21 of the El Malpais NCA Ranger Station due to COVID-19 and remodel activities, visitation throughout the NCA increased in FY2021 to 295,174 from 285,621 in FY2020. Average annual visitation from FY 2016 through FY 2021 is 269,832 visitors. Historically, visitor use numbers recorded in the database are collected through a variety of methods including estimates made by recreation staff based on data from the nearby National Park Service's El Malpais Visitor Center and El Malpais' special recreation permits. Recreation deployed new TRAFx vehicle counters FY21 with the intention to place more in FY22. In the Recreation Management Information System, the current estimated annual visitation is reported less accurately than data that TRAFx counters will provide in the future. Visitation in the NCA is steady throughout the year with the highest overall use from spring to summer. Elk and pronghorn hunting are popular in the NCA with open seasons from August through December 15. We expect that visitation to El Malpais NCA will increase over the years due to population increase and increased interest in outdoor activities.

### Partnerships

Partnership with the neighboring El Malpais National Monument (NPS) staff continues to strengthen. Communication with the NPS staff is open and collaboration is occurring on projects such as sign plans, interpretation, and a reroute of the Continental Divide Trail. The BLM will also be partnering with the NPS to develop a sign plan to inform visitors to both the National Monument and the NCA about WWII munitions. In September of 2021, BLM and NPS partnered together for Public Lands Day to bring volunteers together to clean up some of our most frequented sandstone features, La Ventana Natural Arch and Sandstone Bluffs. We shared resources and a risk assessment, cutting down project planning time and cost.

The Continental Divide Trail (Trail) traverses the NCA and National Monument for more than 40 miles. This NCA section of the trail winds among the Chain of Craters and passes through piñon, juniper, ponderosa pine and a variety of shrubs and grasses. It is approximately 20 miles from CR 42 trailhead to the CR 42 trailhead, however a large majority of visitors, however, use Hwy 117 as a more direct route to hike north into Grants. For the past several years, the State Office has been working on a land exchange with Acoma Pueblo to facilitate a more direct route for CDT hikers near Grants, NM. This exchange is in line with the Trail's mission to keep hiker routes off highways. The BLM, the Trail administration, the Continental Divide Trail Coalition, Park Service, the State of New Mexico, and local Forest Service districts are coordinating routes, improvements, easements, and acquisitions in the area and throughout the state of New Mexico.

El Malpais staff have also been collaborating with Public Lands Interpretive Association (PLIA) and New Mexico State Office (State Office) to develop a local art installation for the NCA. The goal of the art installation is to provide inspiration to visitors to become active land stewards. A large sculpture will be chosen in FY22 and displayed outside the Ranger Station, while a mixed media installation will be curated for inside the Ranger Station in late FY22 to early FY23. PLIA worked with El Malpais park rangers in the creation of 14 videos in two series relaying information to social media followers on resources within the NCA and on Leave No Trace Principles. The NCA is working with the PLIA on the potential for offering a small gift shop in the newly remodeled Ranger Station when it re-opens. A Visitor Guide with safety information, recreation opportunities, resource information, and tribal perspective was completed under an agreement with the PLIA FY21 that will be printed in FY22.

BLM partnered with the Ancestral Lands Youth Corps in a three year Financial Assistance Agreement. The Corps' crews have assisted with trail work in La Ventana Natural Arch Recreation Area, and in the future will assist in the CDT reroute, and with other trails within the El Malpais.

#### Science

In 2019 Rio Puerco Field Office completed the El Malpais Science Plan which is meant to guide the direction of scientific research in the NCA. The Range division completed Rangeland Health Assessments throughout the NCA to determine the status of faunal and floral health of the area. Most areas are considered stable within the NCA.

## **Climate Impacts and Resiliency**

In 2016, a study was completed in the neighboring El Malpais National Monument by Henri Dee Grissino-Mayer with the purpose reconstructing climate for the El Malpais region from long-lived trees and remnant wood, reconstructing the fire history of forests in the El Malpais, and investigating short-term and long-term relationships between wildfire and climate. The conclusion of this study was that the, "presettlement fire regime emphasizes that the current absence of fire in the monument exceeds the historical range of variability established for the presettlement period. Unless effects of past human related disturbances are mitigated, fire regimes of El Malpais will continue to favor high-intensity, catastrophic fires" (Grissino-Meyer 2016).



In 2019, a study was done to determine the "Ponderosa pine resilience to climate change" (Chavez 2019). The study found that ponderosa pine resilience is low. It is possible that current thinning treatments have increased deeper soil moisture to a point where ponderosa pine survival is facilitated, but the impact of thinning treatments in the future remains uncertain. Small changes can significantly alter the projection of ponderosa pine resilience. Therefore, a monitoring program is recommended to obtain measured meteorological, soil moisture, and soil water potential data in Cebolla Wilderness Area. This data would improve the BLM's understanding of soil moisture changes and projections for ponderosa pine resilience as the climate changes.

Future studies should be supported within the El Malpais to understand climate impacts and resiliency.


### Social and Environmental Justice

A Visitor Satisfaction Survey at La Ventana Natural Arch Recreation Area, Joe Skeen Campground, and the El Malpais Ranger Station Recreation Site was completed in 2019 which gave a glimpse at the demographics of visitors to the NCA. Though we lack detailed information regarding our visitors and the impacts of the NCA on surrounding communities, BLM is making a national effort to provide Field Offices with more support and training on identifying and clarifying those impacts.

#### Events

A National Public Lands Day event was held at La Ventana Natural Arch Recreation Area on September 24, 2021. Rio Puerco Field Office and National Park Service partnered in this event. Along with several federal employees, 14 volunteers dedicated their time to remove graffiti from the sandstone beneath La Ventana Arch and assisted in re-graveling a portion of the trail.

With assistance from PLIA, El Malpais park rangers created a series of eight videos about Leave No Trace Principles and a series of seven videos about El Malpais resources which were posted on PLIAs homepage throughout FY2021. These videos were viewed more than 7,000 times and reached more than 21,000 social media followers.
