Welcome and Introductions

Review of May Meeting Minutes

• The council recommended an amendment to the minutes to reflect that the livestock corrals discussed in recommendations were at Johanson's Corrals, not at Swinging Bridge.

San Rafael Swell Recreation Area Review of Planning Process Presentation

- Presentation by Amber Koski
- Review of Land Use Plan Amendment process includes Scoping, Analysis of the Management Situation, Special Recreation Management Area Review, and Area of Critical Environmental Concerns Evaluation. Goal is to reconcile what Congress requires and what Resource Management Plan requires.
- Federal Land Policy Management Act of 1976 established the authority and requirements for lands managed by BLM. Passage of the Dingell Act required Land Use Plans to be amended as needed.
- Resource Management Plans set goals, objectives, and management direction; provide framework for BLM undertakings. Plan Amendments narrower in scope than Resource Management Plans. Focus of this amendment is on how much or how little new San Rafael Swell Recreation Area designation requires changes to existing management.
- Public scoping is collaborative and multi-jurisdictional part of planning process.
- Analysis of the Management Situation (AMS) is internal document, not required for the Environmental Assessment, but helps BLM determine opportunities to resolve planning issues. Helps identify issues to

be addressed in the amendment. Essentially a snapshot of what is happening on the ground. Provides information useful for developing the affected environment and preliminary alternatives in Environmental Assessment. Steps include gathering data and information for the planning area, identifying conflicts/trade-offs between resource protection/uses, gathering existing data/information, collecting new data/information, and analyzing/documenting.

- Special Recreation Area(s) Review not required but helpful for alternative development. Definitions from BLM Manual 8320:
 - Recreation Management Area (RMA) unit (area) where recreation and visitor services objectives are recognized as a primary resource management consideration and specific management is required to protect the recreation opportunities.
 - Special Recreation Management Area (SRMA) –administrative unit where existing or proposed recreation opportunities and Recreation Setting Characteristics are recognized for their unique value, importance, and/or distinctiveness, especially as compared to other areas used for recreation.
 - Recreation Management Zones (RMZ) division of a Special Recreation Management Area delineating specific recreation opportunities.
 - Extensive Recreation Management Area (ERMA) administrative unit that requires specific management consideration to address recreation use, demand, or Recreation and Visitor Services program investments.

Special Recreation Management Areas generally managed to protect and enhance specific things while Extensive Recreation Management Areas managed to protect and enhance multiple resources.

- Overlapping and Adjacent Management Area Designations maps discussed. Three Recreation
 Management Zones overlap or are adjacent to the newly designated recreation area making it a
 complicated management area. Existing Special Recreation Management Areas and Recreation
 Management Zones will determine if management is consistent with legislation and if additional
 management or changes to existing management are necessary. Moving to outcome-based objectives.
- Question from council member about management style moving to outcome-based and how changing
 political leadership will affect that. BLM acknowledged complexity of the situation and described
 science-based process through which decisions are made when modifying management plans while
 applying legal requirements. BLM acknowledged the need for management to protect resources which is
 the goal of plan amendments.
- Areas of Critical Environmental Concern Evaluations highlight areas where special management
 attention is necessary for resource protection. Uses changed since 2008 Resource Management Plan.
 BLM policy discourages overlapping designations, looking to determine if special management is still
 needed given the Dingell Act designations. Contractor will be preparing this report.
- Council member request to consider fewer restrictions, better management, maintaining partnerships.
- Alternative Development must be effective (incorporate Dingell Act requirements), practical, and within BLM jurisdiction. The alternatives consist of Management Goals, Objectives, Actions, and Allowable

Uses. BLM and contractor will host workshops for developing range of alternatives with BLM specialists and cooperating agency representatives.

• Council member discussion about outcome-based management direction, expansion of planning area boundaries, and congressional decisions. BLM advised that in Environmental Assessments, sometimes impact is greater than designated area and indirect impacts as well as related activities occurring on the fringes of the designated area can be considered by increasing the planning area boundary. BLM is unable to change the recreation area boundary and must balance multiple layers of planning while meeting Dingell Act/Federal Land Policy Management Act of 1976 needs and be understood by the public. Management and Planning processes aim to capture concerns and follow legal designations.

Land Use Plan Amendment Scoping Period Report Presentation

- Presentation by Amber Koski
- Scoping report results include refined planning area, refined purpose and need, refined preliminary planning criteria, preliminary alternatives, and incorporates Recreation Area Advisory Council input where appropriate. Scoping began October 28, 2021, and lasted 71 days total.
- Refined planning area and management plan scope defines planning area to help identify current conditions, trends, resource uses, social and economic conditions relevant to the area, and determines known thresholds, constraints, and conditions. BLM makes decisions for the area but considers how other areas interact. On maps, planning area boundary is blue, recreation area is green, recreation management zones crisscross. Refined Purpose and Need includes distinct purposes for each plan and is documented in Scoping Report which will be posted/sent out soon.
- Name of Resource Management Plan Amendment changed to San Rafael Swell Special Recreation Management Area.
- Refined Planning Criteria defines how we analyze potential impacts to resources and uses. Describes framework for issues in the National Environmental Policy Act analysis and is updated to be specific to issues raised in public scoping. Planning Criteria will be familiar to people as they are things people have already seen in the Dingell Act and BLM policy.
- Council member asked question about what issues were most popular. BLM responded that most were for the recreation area and a couple were for cherry-stemmed roads and wilderness.
- Three documents being released simultaneously: Scoping Report, Area of Critical Environmental Concern Report, and Plan Maintenance for Wilderness areas.
- Discussion of Plan Maintenance and explanation that inside wilderness areas, BLM does not have authority to change what Congress has passed.

Visitor Use and Recreation Project Updates Presentation

- Presentation by Jaydon Mead
- Use of TRAFx counters for tracking visitor use, installed in 2021. "D" on chart indicates figure is divided by two. Chart is main access points. Vehicle considered about three people. Covid's effects on

numbers are considered. Motorized trails all similar. TRAFx monthly totals showcase spring and fall peaks with spring being highest. Lower use on weekdays. Emery County purchased ten more counters and is working with BLM to get them installed this fall for 2023 data, focusing on main county roads and Swell access.

- Council member comment that data could be skewed on years the San Rafael River is floated because of shuttling river floaters.
- Council member comment regarding improving the turnaround after the boat launch and the Swinging Bridge takeout.
- Discussion of equipment options for determining type of vehicle and different uses, various mapping applications, and issues with maintaining accurate data for the public.
- Cane Wash update: signed Environmental Assessment on July 21, 2022, will implement decision this fall.
- Justensen Flat Trailhead update: still working on equestrian use and drainage issues, have grant funding, waiting on construction to go out to bid, toilet purchased and delivered for next spring season, goal to finish parking lot before spring.
- Rock Project with Back Country Horsemen update: Back Country Horsemen received two Emery County Trails grants, over 3,500 feet of boulder lines installed near Swinging Bridge/Equestrian Campground and Goodwater Rim trailheads. Continued plans for having more boulders installed and to improve trailheads and signage in areas like Johanson's Corral.
- Swinging Bridge Campground update: new fence being installed around Swinging Bridge North and Equestrian Campgrounds. Will be first site to utilize recreation.gov for scan and pay feature that does not require internet. Reservation options will be discussed in the future.
- Council member suggested reservations for group sites and leaving individual sites as first come, first served.
- Swinging Bridge will be first for fees, then Price Canyon Recreation Area and Swasey's Beach.
- Temple Mountain Town Site and South Temple Wash update: site improvements, road base added, will be ready for next spring.
- Buckhorn Draw update: ordering more signs, finishing kiosks. Intern doing a campsite inventory to keep track of dispersed camping.
- Previous recommendations and progress:
 - Rock Art sites: meeting scheduled with State Historic Preservation Office, Emery County
 Historic Preservation Commission and BLM for project discussion, role clarification. Trail cams
 installed at Buckhorn Panel and rock barricade was fixed at Silent Sentinel.
 - Signage: working with partners on five sign developments Buckhorn Wash, Bellevue Flats,
 Justensen Flats, Fossil Point, and general/travel information.
 - Travel Management: recommendation will be considered when time comes for decision on San Rafael Swell Travel Management Plan.

- Johanson's Corral: working with Back Country Horsemen to install tie rail, have plans to develop signs for clarifying proper parking and highlight multiple use needs. Tie rail should be finished before spring.
- Camping: implementing three campground developments that will be new fee sites in January 2023, working on planning. Request from BLM that council members think about camping options such as if BLM should close dispersed camping near developed campgrounds, limit camping to dispersed campsites in key areas, leave areas available for free and unconfined dispersed camping, how to clarify where free dispersed camping is allowed, where it is limited to designated and where closed/limited to fee sites. Have workshops planned with contractors. Council should consider those questions for future meetings and discussions.

Public Comments

- Larry Ellertson expressed desire to have the intent language penned by Senator Romney and
 Representative Curtis in response to the Dingell Act be considered in the planning process. Stressed the
 value of preserving the original intent of the recreation area. Intent language is intended to be from
 sponsors of legislation. Council member asked if legislation is being honored and how the Travel
 Management Plan affects the access of cherry-stemmed roads within the recreation area. BLM clarified
 that cherry-stemmed roads are not part of wilderness and that existing roads on existing plans are
 followed.
- Ray Peterson expressed importance of clarifying that the Planning Area and the Recreation Area boundaries are different things and having them both separated on maps is valuable. Was happy to see raw data and BLM partnerships. Articulated need for data collection on river floaters and potential permitting/fee collection system. Suggested that BLM not allow industry to dictate management with the example that industry will continue to increase vehicle size and BLM should not feel obligated to accommodate all use. Encouraged to see such progress on projects. Recommended local management of fee/reservation system be used in lieu of recreation.gov.
- No virtual attendees had comments.
- Public comment period closed after council member motion.

Council Member Recognition

 Commissioner Kent Wilson commissioner seat will change due to recent elections and Rod Player and Les Wilberg terms expire on September 10. These council members were recognized for their contributions.

Advisory Council Discussion and Recommendations

• Intent letter from Senator Romney and Representative Curtis was shared, read, and discussed. Copies were distributed to council members. It is public congressional record.



- Council member motioned that when BLM looks at Dingell Act, they also look at the two documents as well. Motion seconded. All in favor, none opposed.
- Discussion of industry affecting management with examples of locations where overused areas need
 attention (exit 131 and behind the Reef). Suggestion that dispersed use and recreation areas be
 inventoried, question about how to measure those impacts. BLM noted that human-built fire rings have
 been counted at the Wedge and behind the Reef. Route evaluations factor some information into the
 process.
- Council member suggested that BLM spend equal time and effort on the ground dealing with local area issues as is spent on upper management regulations to stay ahead of increasing use trends. Also discussed the value of field trips.
- Council member motioned to appreciate the work done in the Recreation Area and support recreation projects outside of the Recreation Area. Motion seconded. All in favor, none opposed.

• Possible agenda items will wait to be discussed as council vacancies need to be filled before having a full quorum and may take some time. BLM will call on current and new boards members once established to look at dates for next meeting before scheduling the Federal Register Notice. Will likely be after the first of the year.

certain lands to Calista Corporation, an Alaska Native regional corporation, pursuant to the Alaska Native Claims Settlement Act of 1971 (ANCSA). The lands approved for conveyance lie entirely within Clarence Rhode National Wildlife Range now known as the Yukon Delta Wildlife Refuge. As provided by ANCSA, ownership of the subsurface estate in the same lands will be retained by the United States.

DATES: Any party claiming a property interest in the lands affected by the decision may appeal the decision in accordance with the requirements of 43 CFR part 4 within the time limits set out in the **SUPPLEMENTARY INFORMATION** section.

SUPPLEMENTARY INFORMATION: As required by 43 CFR 2650.7(d), notice is hereby given that the BLM will issue an appealable decision to Calista Corporation. The decision approves conveyance of surface estate in certain lands pursuant to ANCSA (43 U.S.C. 1601, *et seq.*), as amended. Ownership of the subsurface estate will be retained by the United States.

The lands are located within the Yukon Delta National Wildlife Refuge, in the following townships, and aggregate 78.31 acres: T. 15 N., R. 86 W., Seward Meridian (SM); T. 10 N., R. 88 W., SM; T. 15 N., R. 88 W., SM; T. 17 N., R. 88 W., SM; T. 18 N., R. 88 W., SM; T. 10 N., R. 89 W., SM; and T. 12 N., R. 89 W., SM.

The decision addresses public access easements, if any, to be reserved to the United States pursuant to Sec. 17(b) of ANCSA (43 U.S.C. 1616(b)), in the lands approved for conveyance.

The BLM will also publish notice of the decision once a week for four

consecutive weeks in "The Delta Discovery" newspaper.

Any party claiming a property interest in the lands affected by the decision may appeal the decision in accordance with the requirements of 43 CFR part 4 within the following time limits:

1. Unknown parties, parties unable to be located after reasonable efforts have been expended to locate, parties who fail or refuse to sign their return receipt, and parties who receive a copy of the decision by regular mail which is not certified, return receipt requested, shall have until June 3, 2022 to file an appeal.

2. Parties receiving service of the decision by certified mail shall have 30 days from the date of receipt to file an appeal.

Parties who do not file an appeal in accordance with the requirements of 43 CFR part 4 shall be deemed to have waived their rights. Notices of appeal transmitted by facsimile will not be accepted as timely filed.

The Council will host a field tour on May 24 to the San Rafael Swell Recreation Area, which features badlands of brightly colored and wildly eroded sandstone formations, deep canyons, and giant plates of stone tilted upright through massive geologic upheaval. The recreation area offers numerous recreational opportunities including hiking, biking, four-wheel driving, horseback, canyoneering, and river running. Members of the public are welcome on the field tour but must provide their own transportation and meals. Individuals who plan to attend

must RSVP at least one week in advance of the field tour to the contact listed in the FOR FURTHER INFORMATION CONTACT section of this notice. SUPPLEMENTARY INFORMATION: The Idaho RAC is chartered, and the 15 members are appointed by the Secretary of the Interior. Their diverse perspectives are represented in commodity, noncommodity, and local interests. The Idaho RAC serves in an advisory capacity to BLM officials concerning issues relating to land use planning and management of public land resources located within the State of Idaho. The Idaho RAC formed the Lava Ridge Subcommittee to compile information, conduct research, and report their recommendations to the full Council for consideration. The BLM Shoshone Field Office is currently developing an **Environmental Impact Statement to** analyze the proposed Lava Ridge Wind Energy Project, a commercial-scale wind energy facility that is proposed to be constructed on BLM-managed public land in southern Idaho.

The June 15 Subcommittee and RAC field tour is to sites associated with the proposed Project. The public comment period for the Wednesday, June 15, 2022, field tour will be held at 4:45 p.m.

The July 7 Subcommittee meeting will focus on providing background information on the proposed Project, the NEPA process, and stakeholder prospective. The August 25 Subcommittee meeting will include a review of the Draft Environmental Impact Statement (DEIS) and presentations on alternatives. The September 22 Subcommittee meeting will focus on compiling information for consideration of the RAC on the DEIS alternatives. The October 19 RAC meeting will include State Director and District Office updates; a presentation on the Payette River System Draft Business Plan; an update on the proposed Project, a presentation on Subcommittee findings relating to the proposed Project, and development of associated RAC recommendations; and a presentation on Bipartisan Infrastructure Law implementation and projects.



Wedge Campground Planning Update

Rock Art Site Recommendation

- 2/17/2021 "Consider adding rock art protections like fences, new signs, ect."
- 5/25/2022 "Prioritize protection of cultural sites over individual campsites."
- On September 14th, there is meeting scheduled with the State Historic Preservation Office, the Emery County Historic Preservation Commission, and the BLM to further discuss site project priorities, clarify each partners role, and hopefully schedule a few projects.
- In addition to that, we have also installed trail cameras at the Buckhorn Panel, and fixed the rock barricade at the Silent Sentinel, which was a site we visited during the field trip in May.

Signage Recommendation

2/17/21 "BLM add signage to next agenda. Review details and options for how to improve signage and education. (Talk to Emery County and look at other areas for ideas)"

BLM presented about signs at the following meeting. We shared our sign inventory, we showed how we were improving our signage, and we shared challenges we face.

BLM is currently working with Emery County on 5 sign development priorities. Buckhorn Wash Campground, Bellevue Flats Trailhead, Justenson Flats Trailhead, Fossil Point Trail, and General/Travel Info.

Travel Management Recommendation

2/17/2021 "Keep all currently used routes in the San Rafael Swell Recreation Area open and maintain those roads and trails."

This recommendation will be considered by management when its time to make a decision on the San Rafael Swell Travel Management Plan.

Back Country Airstrip Recommendations

8/10/2021

Conversation on back country airstrips should be added to the agenda for the next meeting.

BLM presented and gave details about the 5 backcountry airstrips that are located within the San Rafael Swell Recreation Area.

Johansson Corral Recommendation

5/25/2022

"Johanson Corral needs a kiosk explaining multi-use needs of all user groups. Tie rails should be installed on the south end for horses allowing cattlemen to get in and out particularly from February to May. Specific parking areas should be defined for vehicles using the wilderness area. Designate a small vehicle parking area on the west end."

We are working with the Backcountry horsemen to install a tie rail. We have plans to develop new signage for the area to clarify how to properly park and to highlight the multiple use needs at that site.

Camping Recommendations

2/17/2021 "Be more pro-active for camping, think about where it is appropriate, consider camping only in designated sites, review where dispersed camping is allowed."

5/25/2022"BLM should continue implementing developed campgrounds and should continue planning for new infrastructure at the Wedge and Wikiup to better manage the increasing use"

We are currently implementing campground developments that will become fee sites in January 2023. Future camping decisions will need to be made during our land use amendments and/or during the recreation area planning efforts.

Possible camping restrictions/clarification in the recreation area

Should the BLM close dispersed camping near developed campgrounds, and if so, how large should that closure be?

Should we limit camping to designate dispersed campsites in key areas such as the behind the reef road? Where else?

Should we leave areas available for free and unconfined dispersed camping?

How can be best clarify where free dispersed camping is allowed, where it is limited to designated, and where it is closed/limited to fee sites? Is it best to establish these polygons/area for the entire recreation area?
