Clover Mountains Wilderness

Legal Boundary Description

The boundary of the Clover Mountains Wilderness established in the "Lincoln County Conservation, Recreation, and Development Act of 2004", Public Law No. 108-424, dated November 30, 2004, Bureau of Land Management serial No. 79847, is located in Township 5 South, Range 67 East; Townships 6 South, Ranges 67, 68, and 69 East, Townships 7 South, Ranges 67, 68, 69, and 70 East and Townships 8 South, Ranges 67, 68, and 69 East, Mount Diablo Meridian, Lincoln County, in the State of Nevada, and is more particularly described as follows:

- 1. BEGINNING at the corner of Tps. 5 and 6 S., Rs. 67 and 68 E., thence easterly, a distance of approximately 0.25 miles, on the line between sections 6 and 31, on the south boundary of T. 5 S., R. 68 E., to a point on said line, at approximate latitude 37°27'45" North, longitude 114°25'40" West;


END OF DESCRIPTION
