This is the final legal description as required in Section 1972(G) of the above mentioned Act. It describes the boundary for the Deep Creek Wilderness Area located in Washington County, Utah and managed by the Bureau of Land Management. The boundary is more particularly described as follows:

Beginning at point 1, the corner of sections 1, 2, 35, and 36, Townships 39 and 40 South, Range 10 West, Salt Lake Meridian, Utah.

Thence northerly between sections 35 and 36 to point 2, the 1/4 section corner of sections 35 and 36.

Thence westerly along the east-west centerline of section 35 to point 3, the center W 1/16 section corner of section 35.

Thence northerly along the north-south centerline of the NW 1/4 of section 35 to point 4, the W 1/16 section corner of sections 26 and 35.

Thence easterly between section 26 and 35, to point 5, to the intersection of a line parallel with and 30 feet northwesterly of the centerline of a road.

Thence northeasterly, parallel with and 30 feet northerly of the centerline of the road, through sections 26 and 25, to point 6, at the intersection with the north-south centerline of section 25.

Thence northerly along the north-south centerline of section 25 to point 7, the 1/4 section corner of sections 24 and 25.

Thence westerly between sections 24 and 25 to point 8, the W 1/16 section corner of sections 24 and 25.

Thence northerly along the north-south centerline of the SW 1/4 of section 24 to point 9, the center W 1/16 section corner of section 24.

Thence westerly along the east-west centerline of section 24 to point 10, the 1/4 section corner of sections 23 and 24.

Thence northerly between sections 23 and 24 to point 11, the corner of sections 13, 14, 23, and 24.

Thence westerly between sections 14 and 23 to point 12, the 1/4 section corner of sections 14 and 23, which also serves as point 1, of the Deep Creek North Wilderness Boundary.

Thence westerly between sections 14 and 23, to point 13, the corner of sections 14, 15, 22, and 23.

Thence westerly between sections 15 and 22, to point 14, the E 1/16 section corner of sections 15 and 22.

Thence southerly along the north-south centerline of the NE 1/4 of section 22 to point 15, the NE 1/16 section corner of section 22.

Thence easterly along the east-west centerline of the NE 1/4 of section 22 to point 16, the N 1/16 section corner of section 22 and 23.

Thence southerly between sections 22 and 23 to point 17, the S 1/16 section corner of sections 22 and 23.

Thence westerly along the east-west centerline of the SE 1/4 of section 22, to point 18, the SE 1/16 section corner of section 22.

Thence southerly along the north-south centerline of the SE 1/4 of section 22 to point 19, the E 1/16 section corner of sections 22 and 27.

Thence westerly between sections 22 and 27 to point 20, the 1/4 section corner of sections 22 and 27.

Thence southerly along the north-south centerline of section 27 to point 21, the center 1/4 section corner of section 27.

Thence easterly along the east-west centerline of section 27 to point 22, the 1/4 section corner of section 26 and 27.

Thence southerly between sections 26 and 27 to point 23, the S 1/16 section corner of sections 26 and 27.

Thence westerly along the east-west centerline of the S 1/2 of section 27 to point 24, the S 1/16 section corner of sections 27 and 28.

Thence southerly between sections 27 and 28 to point 25, the corner of sections 27, 28, 33, and 34.

Thence easterly between sections 27 and 34 to point 26, the W 1/16 section corner of sections 27 and 34.

Thence southerly along the north-south centerline of the NW 1/4 of section 34 to point 27, the center W 1/16 section corner of section 34.

Thence westerly along the east-west centerline of section 34 to point 28, the 1/4 section corner of sections 33 and 34.

Thence westerly along the east-west centerline of section 33 to point 29, the center W 1/16 section corner of section 33.

Thence northerly along the north-south centerline of the NW 1/4 of section 33 to point 30, the NW 1/16 section corner of section 33.

Thence westerly along the east-west centerline of the NW 1/4 of section 33 to point 31, the N 1/16 section corner of sections 32 and 33.

Thence southerly between sections 32 and 33 to point 32, the corner of sections 4, 5, 32, and 33, Townships 39 and 40 South, Range 10 West, Salt Lake Meridian, Utah.

Thence easterly between Townships 39 and 40 South, Range 10 West to point 1, the corner of sections 1, 2, 35, and 36 and point of beginning.
