Legal Descriptive Boundary of Baboquivari Peak Wilderness, designated by the Arizona Desert Wilderness Act of 1990, 104 STAT. 4469, Public Law 101-628, dated November 28, 1990.

This is the final legal description of the Baboquivari Peak Wilderness boundary as required in section 101(c) of the Arizona Desert Wilderness Act. It describes the boundary for Baboquivari Peak Wilderness, located in Pima County, Arizona.

All lines of the Public Land Survey System and the boundary of the Tohono O'odham Indian Reservation (formally "Papago Indian Reservation"), along the summit of the Baboquivari Mountains, referenced in this description are according to the latest official survey plats and notes unless otherwise specified.

The boundary is more particularly described as follows:

Beginning at the closing corner of the boundary of the Tohono O'odham Indian Reservation at intersection with the west boundary of T. 18 S., R. 8 E., from which the corner of sections 19, 24, 25 and 30, T. 18 S., R. 8 E., bears South, 262 ft., and the 5th mile monument of said Reservation boundary, as described in book 3762 of the survey of the "Boundary of Papago Indian Reservation", executed by Otis O. Gould, U.S. Transitman, in 1926, bears S. 54°45' W., 62.7 ft. dist.;

Thence southwesterly along the boundary of the Tohono O'odham Indian Reservation, as described in said survey, along the summit of the Baboquivari Mountains, in unsurveyed T. 18 S., R. 7 E., and partially surveyed T. 19 S., R. 7 E., 6.13 miles, to the witness corner to the 11th mile monument of said boundary, identical with the closing corner at intersection with the boundary of the Tohono O'odham Indian Reservation and the line between sections 14 and 23, partially surveyed T. 19 S., R. 7 E., also identical with AP1;

Thence East, immediately leaving a portion of the boundary of the the Tohono O'odham Indian Reservation, on the line between sections 14 and 23, to the corner of sections 13, 14, 23 and 24, partially surveyed T. 19 S., R. 7 E.;

Thence N. 89°55' E., on the line between sections 13 and 24, partially surveyed T. 19 S., R. 7 E. to the 1/4 section corner of sections 13 and 24;


