In fiscal year (FY) 2022, the Glennallen Field Office (GFO) completed site improvement projects at Brushkana Creek Campground and Clearwater Wayside. Projects included installation of new entrance signs, campsite markers, maintaining site trails, cleaning fire rings, graffiti removal, and providing janitorial services and maintenance for the site.

Vault Toilet Pumping Contract

During FY2022, GFO maintained a janitorial contract to keep vault toilet facilities cleaned and sanitized. The field office utilized a local contractor to pump vault toilets at four developed campgrounds and two waysides within GFO. Supplies such as trash bags, hand sanitizer, safety equipment, and toilet paper were purchased. Staff kept facilities clean and functional for the enjoyment of visitors.
