In FY22, the Kingman Field Office (KFO) partnered with Scouts to complete site improvement projects at the Burro Creek, Wild Cow Springs, and Windy Point Campgrounds. The Scouts installed site markers, maintained site trails, cleaned fire rings, and removed graffiti.

In FY22, KFO replaced water and sewer utilities at the Burro Creek Campground. Fee monies were used to supplement the project which was funded predominately by the Great American Outdoors Act. 5,537 feet of potable water and sanitary utility lines were replaced and the roof of the water storage tank was repaired to keep out contaminants. Fee money was used to monitor the project and install a potable water filtration system that ensures the water is safe for public consumption.

Recreation Fee Dollars

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation
- Direct operating or capital costs associated with the recreation fee program

Burro Creek Campground access road to repair

- Funding will aid the design for road repairs to the 1mile paved Burro Creek Campground access road that is used by recreationists to access the site - \$3,200.00
- Fund a host at the Burro Creek Campground \$4,500.00
- Fund a janitorial contract for the Burro Creek Campground - \$10,000.00
- Fund a grader rental to repair site roads in Burro Creek Campground - \$19,000.00
- Fund operations and maintenance of three fee sites -\$20,146.00
- Construct a block wall at the Burro Creek Campground to mitigate flooding at the upper restroom facility -\$3,300.00
- Continue to partner with external organizations to facilitate projects at recreation fee sites - \$2,860.00

Connecting with Communities

Since 2012, the KFO has proactively partnered with local-area scout organizations to conduct service projects both at recreation fee and non-fee sites. Projects have ranged from as simple as resurfacing picnic tables to as complex as designing and constructing non-motorized trails. The KFO has also facilitated several Eagle Scout Merit Badge projects in cooperation with various scout organizations. KFO has developed and led interpretive talks on BLM's mission, resources, values, and career opportunities. These projects have proven over time to support BLM's goal of proactively engaging with communities through identifying and developing outcome-focused partnerships with community service providers (e.g., scout troops). Scout troops are typically from the surrounding communities of Bullhead City, Kingman, and Golden Valley, AZ. Bullhead City and Golden Valley are considered communities with environmental justice concerns due to higher poverty rates. In addition, Bullhead City falls within and adjacent to a Tribal community.
