Connecting with Communities

Recreation is a major draw for Lake Havasu's 10 million annual visitors. The implementation of fishery improvements has resulted in Lake Havasu becoming a top-rated fishing lake that hosts multiple tournaments annually. The Lake Havasu Field Office has played a key role in the Lake Havasu Fisheries Improvement Partnership since its inception in 1992. The partnership, which is a successful and nationally recognized cooperative program, improves both artificial and natural habitats to enhance fishing opportunities. Between 1992 and 2004, the partnership improved approximately 875 overall lake acres within 42 coves or cove complexes. The artificial structures improve angling by concentrating fish in one area and providing refugia for young fish. Lake Havasu Field Office is dedicated to providing the best possible recreational opportunities while also maintaining the quality of the resources.
