Recreation fee dollars supported the purchase of a new steel ramada at the Murray Springs Clovis Site on the San Pedro Riparian National Conservation Area. Labor for the installation of the ramada was provided by Tucson Field Office (TFO) staff and volunteers during a National Public Lands Day event in November 2021. The ramada replaced a shade structure composed of mesquite that collapsed in 2017.

Recreation fee dollars supported the purchase of new signs for recreation sites in the Las Cienegas National Conservation Area. The new signs were installed by a youth crew from Arizona Conservation Corps in June 2022. A variety of signs were installed to help users familiarize where to camp and understand the purpose of the group sites for Special Recreation Permit holders.

Planned Activities



Wildlife interpretive sign requiring replacement Interpretive sign replacement at Empire Gulch. Existing signs are weathered and unreadable. Estimated cost: \$1,500.

Update Las Cienegas National Conservation Area bird watching checklist pamphlet. Las Cienegas is a popular bird watching area for both public users and wildlife viewing tour groups. Estimated cost: \$500.

Install new steel camp fire ring devices for designated group sites in the Las Cienegas National Conservation Area and Ironwood Forest National Monument. Estimated cost: \$2,000.

Replace sitting benches at Presidio Santa Cruz de Terrenate interpretive site in the San Pedro Riparian National Conservation Area. Estimated cost: \$2,500.

Connecting with Communities

The TFO continues its collaborative engagement with stakeholders and local partnership groups to help improve recreation opportunities and experiences for visitors. The recreation technical teams created last year in the Las Cienegas and San Pedro Riparian National Conservation Areas continue efforts with local community team members to assist with recreation site improvement needs, identifying recreation objectives to be accomplished from resource management plans, and providing information to the recreation staff on changing recreation trends on public lands. These efforts support External Goal 1: Support Community Service Providers While Balancing the Interests of All Public Lands Users and Strategic Focus 1: Proactively Engage with Communities.

TFO's recreation program is continuously working on implementing upgrades to designated campgrounds and group sites to meet user demand while reducing the potential for conflict between different recreation user groups. Draft plans are developed by staff and shared with partner groups and stakeholders to ensure public concerns are being addressed.
