In NE California, Pit River Campground and Day use area is just a few steps away from incredible Pit River. Opportunities for recreation include swimming, angling, picnicking, birding, kayaking, river rafting and camping. The 8 campsites offer fire rings, tables, and BBQs with 2 wheelchair accessible restrooms. Collections from recreation use fees and interagency passes were used for routine maintenance, law enforcement, and overhead costs.

Amount Expended: \$8,625.56

### **Recreation Fee Dollars**

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation
- Direct operating or capital costs associated with the recreation fee program

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.

Amount Expended: \$5,575.82



## Other Accomplishments

Developed partnership with the Fall River Lions Club to accommodate recreation opportunity at the Pit River Campground.

Developed partnership with American Whitewater promoting Pit River recreation, and increased water flows for all paddlers.

Pit River Camp Host is on site to answer questions from campers and day use visitors, also improving fee compliance.

Developed partnership with PG&E to provide up to date water flow information regarding Pit River recreation opportunities.

Secured AmeriCorps work crew for labor prior to opening of Pit River Campground for seasonal recreational activity.

The Pit River campground provides a low-cost recreation alternative for local communities, such as McArthur, Fall River Mills, and Cassel to enjoy the benefits of the outdoors. We collaborate with the local Lions Club and PG&E to provide current info to the public, assure recreators have an enjoyable experience, while contributing to the overall success of the local economy.

The Pit River tribe consists of eleven autonomous bands, all of whom traditionally lived along the Pit River watershed in Northeastern California. The Tribe consults with Applegate Field Office as part of tribal consultation efforts in their ancestral homeland. The BLM works closely with the Tribe on environmental conservation projects as proposed.
