#### Catching a ride at the North Jetty The Arcata Field Office plans to use future 1232 funds towards custodial support for restroom cleaning and trash collection at day use sites in the next fiscal year. A new, additional vault toilet will be installed at Samoa Dunes Recreation Area to address the increase in visitor use. The bathroom will service a highly visited area at the dunes where visitors are able to view the Humboldt Bay Harbor Entrance, as well as the many surfers venturing out to 'catch a ride' at the North Jetty.

### **Connecting with Communities**

On June 2, more than 700 children from Humboldt County, California schools converged on a Pacific Ocean beach managed by the Arcata Field Office as part of the 17th annual Ocean Day education and beach restoration event. The BLM and its partners hosted the event, which took place at the Mike Thompson Wildlife Area, South Spit, Humboldt Bay. The celebration marked the return of the event after a two-year hiatus resulting from the Covid19 pandemic.

As they have for nearly two decades, a local non-profit organization, Friends of the Dunes, joined the BLM, California Conservation Corps, California Department of Fish and Wildlife, and California State Parks and Humboldt County to organize the event.
