

Facility and Route Maintenance



lvanpah Dry Lake vault

Maintain the public lands visitors recreational experience. Cleaning/maintaining 3 different vault toilet facilities found at Amboy Crater (National Natural Landmark), Horse Thief Campground, and Ivanpah Dry Lake. Funding also maintains several multi-panel Information Kiosks and signing and monitoring of over 3200 miles of designated open Off Highway Vehicle (OHV) adventure routes. Routes provide access to multiple other recreation activities; hiking, camping, photography, and 18 Wildernesses.

NFO has no open areas, all activities are under a Special Recreation Permits (SRP) or a Letter of Agreement (LOA). Approximately 20 SPRs and 10 LOAs were issued for several activities. Recreation activities include Hunting Guide, 4 Wheel Drive and Utility Terrain Vehicle Poker Runs and tours, Dual Sport Motorcycle rides and tours, Drone testing, and educational field trips, all occur yearly. Special Recreation Permit fees are the largest source of funding for the Recreation Fee Revenue program.

Amount Expended: \$843.58

Recreation Fee Dollars

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation
- Direct operating or capital costs associated with the recreation fee program



Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.

Land Sailing on Ivanpah Dry Lake Ivanpah Dry Lake and the Area of Critical Environmental Concern received multiple illegal OHV trespass damaging the area. Planning major improvements to the Ivanpah area to include post n cable fencing, locking gates, new access gateway and road. Estimated cost of the gateway and entrance road is \$150,000. Current \$95,621.71 and future funding is targeted to this project. Post in cable and gates are with California OHV grant restoration funds to prevent continued trespass and damage to the site.
