The 1232 fees help fund one Law Enforcement (LE) Ranger on 2.7 million acres of public lands. The LE position does a majority of the monitoring work for the Special Recreation Permit (SRP) program. In 2022 the field office spent \$8000 of revenue to perform these duties:

- Inform hunters on safety, weather, road conditions, rules, and regulations.
- Support and monitor SRP permittees.
- Answer questions.
- Ensure safety and support law enforcement.

The Miles City Field Office (MCFO) manages around 40-50 SRPs annually. In 2022, BLM utilized carryover fees and the support of a permanent fire and fuels staff member to address a backlog of GIS work. The ability to carry over fees for several years was critical in obtaining help and completing an accurate GIS layer file. With this accurate GIS data, the MCFO can better serve the public and improve maps for other resources, projects, and monitoring.

- Career seasonal Park Ranger position = \$20,000 carryover funds.
- Law Enforcement Labor = \$7000; funds will be spent to monitor SRPs with law enforcement services including patrols & visitor contacts during peak periods & events.
- Vehicle Use = \$9000.
- Hunter Patrol Labor = \$11,000; carryover funds used for monitoring.
- GIS Labor = \$8,000; specific to GIS work for SRPs.
- Ongoing upkeep & purchase of visitation counting devices = \$6,000.
- New & carryover funds will be used for appropriate sites to purchase signs needed, trash cleanup, and other SRP administration.
- Vault toilet install = \$75,000 \$100,000.

Connecting with Communities

The majority of the SRPs & revenue generated within the MCFO come from permittees that outfit and guide big game hunting. In addition, the field office resides on 2.7 million acres of public lands in 15 counties with very rural areas & a limited population. With the majority of SRPs being outfitters, the FO works with members of the Montana Outfitters and Guide Association (MOGA) & attends an annual meeting they hold for outfitters in Eastern Montana.

All of the fees generated within the MCFO, come from SRPs; by hiring a career seasonal position and/or using funds for current employee's time to help manage, grow, and administer the SRP program aligns with External Strategy, Goal 1: Support Community Service Providers While Balancing the Interests of All Public Lands Users. With most of the SRP permits in the MCFO consisting of Outfitter and Guides, the outfitters often change, add, or delete many of the ranches they lease; (hunt or operate on) which requires administration and GIS challenges on a year-round basis for the ORP. This will help reach that goal and Goal 2 by bringing economic benefits as we continue to support all SRPs.
