Planting Native Vegetation



Cottonwood Planting

Roswell BLM Staff utilized FLREA funds to plant native trees and grass to enhance the Rob Jagers Campground. Due to the construction that took place during 2021, the campground was left with many patches of bare earth. These areas were seeded and grew back during the monsoon season of 2022.

Amount Expended: \$2,000.00

Maintenance and Improvements



Cave Canyon Campground

Fiscal Year '22 FLREA funds were utilized by Roswell Field Office for maintenance and improvements to campgrounds. This included a cleaning contract, vault pumping, a dumpster service as well as purchasing signs and volunteer reimbursements.

Amount Expended: \$4,600.00

Recreation Fee Dollars

They support and enhance:

- Maintenance, repair, and facility enhancement related directly to visitor enjoyment, visitor access, and health and safety
- Interpretation, visitor information, visitor service, visitor needs assessments, and signs
- Habitat restoration directly related to wildlife- dependent recreation that is limited to hunting, fishing, wildlife observation, or photography
- Law enforcement related to public use and recreation
- Direct operating or capital costs associated with the recreation fee program

Recreation fee dollars are an investment in outdoor recreation. Current and future generations benefit as 100% of the funds collected are reinvested in the facilities and services that visitors enjoy, use, and value.
