

Legal Authorities

Wild Free-Roaming Horses and Burros Act, 1971

- Protect and manage wild horses and burros "as components of public lands"
- Maintain a "thriving natural ecological balance"

Federal Land Policy and Management Act, 1976

- Established BLM "multiple-use" mission
- Allowed for motorized vehicles for wild horse and burro management

- To manage wild horses and burros as an integral part of the natural system of public lands
- Goal: healthy herds on healthy public lands





On-Range Program Update - Research

New fertility control research projects launched May and June 2023:

- 1. Cornell University College of Veterinary Medicine and Northwest Wildlife Conservation Research
 - Testing PZP (SpayVac) effectiveness when injected into neck muscle or flank
- 2. USDA Animal and Plant Health Inspection Service's National Wildlife Research Center
 Oocyte Growth Factor fertility control vaccine testing and development

Off-Range Program Update

- Online Corral has held four adoption/sale events so far in FY23 that offered 2,143 animals, of which 1,051 were placed into private care.
- The Mustang Heritage Foundation partnership has placed 2,058 animals into private care so far in FY23, representing 39% of total placements to date.
- Ongoing evaluation of pasture proposals received from a 2021 solicitation for additional off-range space.
- Adoption Incentive Program updates/improvement continue to be considered.








HQ-Issued Policies/Bulletins in FY23

Animal Health and Preparation – On February 27, 2023, the Program updated policy for Animal Health, Vaccination, Gelding and Microchipping of Wild Horses and Burros (IM 2023-028). This IM establishes policy and procedures for evaluating animal health and body condition, providing preventive medical care for animals in holding, gelding (castrating) male wild horses and burros, issuing gelding reimbursement vouchers, and microchipping wild horses and burros.

Comprehensive Animal Welfare Program (CAWP) for Off-Range Pastures — On May 15, 2023, the Program issued new policy for the CAWP for Off-Range Pastures and Public Off-Range Pastures (IM 2023-41). This IM helps ensure humane treatment, handling, and care of wild horses and burros by consolidating BLM's longstanding best practices for animal care and handling, as well as adding training for BLM employees, contractors, and partners.



- On-range awards will be announced soon



Rule-making Process



President's Budget Request FY2024

The President's proposed budget for FY 2024 is \$154.8 million. This budget request will assist the BLM to meet the needs of the WH&B program during a time of unprecedented price increases in the cost of off-range holding.

- The BLM will conduct limited on-range operations. The requested budget allows the program to gather and remove up to 1,500 animals, which may only be suitable for emergency/nuisance situations
- The BLM and its partners continue to support the use of fertility control to slow herd growth, which is most effective once a population is at or near its appropriate management level.
- Off-range holding and caring of animals typically consuming more than 60 percent of the WH&B budget. Focus will be on moving animals from corrals to more cost efficient off-range pastures.
- Continue with private care placement including Adoption Incentive Program.
