- Business to address: The Council does not currently have a chairperson.
- Welcome to new and returning members.

### **Overview of Charter and Responsibilities of Council**

#### Designated Federal Officer, Green River District Manager Lance Porter

- Note: seven members of the Council, Federal Advisory Council Act requires at least half of the council plus one for a quorum. Five members required.
- Council members discussed who to elect as board chair. Unanimously, the Council elected Kent Wilson to serve as board chair, and Rod Player to serve as vice-chair.

### **Dingell Act Update**

#### **BLM Dingell Act Lead, Molly Hocanson**

- See PowerPoint for presentation material.
- Leon asked to provide an update on which parcels will be transferred from BLM to School and Institutional Trust Lands Administration as part of the Dingell Act Land Exchange.
  - Answer: The agency discussed in general School and Institutional Trust Lands Administration parcels inside wilderness areas would be exchanged and transferred to BLM.
- Discussed an overview of Certificate of Inspection and Possession. Certificate of Inspection and Possession surveys for parcels to be acquired will be conducted beginning early September.
- Rod Player what happened to School and Institutional Trust Lands Administration lands outside of Goblin Valley near Little Wild Horse Canyon?
  - Answer: That is a parcel that is to be conveyed to the BLM?
- How would management of lands change after transferred from School and Institutional Trust Lands Administration to BLM?
  - Answer: The management, such as Right-of-Ways, would stay the same.
- Kent Wilson suggests the council later discuss Right-of-ways coming to Emery County.
- Council members discussed reviewing access to School and Institutional Trust Lands Administration lands in Calf Canyon off Buckhorn Draw.

### **Overview of Plan Amendments**

#### **BLM Environmental Coordinator, Stephanie Howard**

- Themes to consider to inform alternatives development:
  - How to better manage existing recreation; general sentiment is the San Rafael Swell Recreation Area is busy enough, no need to promote more recreation.
  - New user created recreation development is increasingly becoming an issue.

- San Rafael Swell Recreation Area has numerous areas of focus, how to we recognize all of these focuses when some conflict?
- Focus on recreation and traditional uses.
- Also, an opportunity to educate visitors.
- Different areas of the SRS may require different management: front country vs backcountry, high use vs more remote areas, areas with more specific resources concerns, etc.

#### San Rafael Swell Recreation Area Highlights

#### **BLM Outdoor Recreation Planner, Jaydon Mead**

- With Scan and Pay sites, council member suggested to always have some method to pay cash at fee sites.
- BLM Price Field Office does not have any land-based user limits; may need to be considered in the future.

### **Public Comment Period**

- Jean Public, received via email
  - As received: "this is nation;a land and owned by 350 millionamericans and under the public trut doctrine. it should be preserved for nature, plants, wildlife, animals to live in peace. get the cattle ranchers off this land. stop the assault on nature. no chemical applications.no fire introduced. i notice you allow only I hour for public comment. that is disrespecting the public who ae to have open and transparent govt. govt of the people by the people.you need to stop disrespecting that. the opinoni of the national people to run their national land is being taken away by officipis agencies. you disrespect the people entirely. our govt is going to pieces because of gthat fact. are all the appointed members cattle grazers. get cattle grazers off our nationalland. they pay cheap cheap cheap rates and their cattle ruin the land. save nature at all costs and permanently. they are not making more land so we need to save and protec fully what we have. this comment is for the public record."
- Jim Jennings (Emery County):

- Wilderness boundaries errors are prevalent; Recommendation for BLM to continue to work on boundary errors.
- Patrick McKay:
  - Is the Devil's Racetrack trail in wilderness? Right-of-Way should have been transferred to Emery County.
  - Encourage to work out a solution to keep Calf Canyon trail open. Work with School and Institutional Trust Lands Administration to keep road open.

### **Council Discussion**

- Council members discussed with agency personnel the process of addressing wilderness boundary errors. The Intent was for wilderness boundaries to follow geologic features and roads. The agency informed them of the process of reviewing and addressing mapping errors on a case-by-case basis.
- Council members discussed as recreation use continues to increase, there will be increased costs associated with road maintenance. Can Emery County find additional funding sources to help cover these costs? They discussed Transient Room Tax funds should be used for promotion of tourism.
- Areas of Critical Environmental Concern Areas of Critical Environmental Concern is there
  value of managing Areas of Critical Environmental Concern within the San Rafael Swell
  Recreation Area?
  - Areas of Critical Environmental Concern doesn't necessarily need to carry forward so long as Relevance & Important values are protected.
  - Are the current boundaries of Areas of Critical Environmental Concern adequate for managing Relevance and Importance values?
  - Table for a future discussion.
- School and Institutional Trust Lands Administration land exchange right-of-way, transfer to Emery County.
  - Recommendation:
  - Council made a formal recommendation that was unanimously supported: BLM will honor previous uses on right-of-ways on School and Institutional Trust Lands Administration parcels as allowed under the Dingell Act.
- Social and environmental carrying capacity?
  - Possible topic for future meetings.
  - May not be possible for the larger landscape, but easier on smaller scale for individual trailheads, campgrounds, etc.
  - Special events provide opportunities for education and outreach.

- Management plan would provide an opportunity for adaptive management to recognize triggers to put limits on recreational use.
- Boundaries
  - Council will assist with wilderness boundary issues.


## Establishment of the San Rafael Swell Recreation Area Advisory Council

- March 12, 2019, the John D. Dingell Jr. Conservation, Management, and Recreation Act was signed into law, establishing, among others, The San Rafael Swell Recreation Area
- The Charter for the San Rafael Swell Recreation Area Advisory Council was signed on December 19, 2019
- The Council is regulated by the Federal Advisory Committee Act

- The San Rafael Swell Recreation Area includes approximately 217,000 acres
- The following Wilderness areas were congressionally designated around the San **Rafael Swell Recreation Area: Big Wild Horse Mesa, Cold** Wash, Devil's Canyon, Eagle Canyon, Horse Valley, Little Ocean Draw, Little Wild Horse Canyon, Lower Last Chance, Mexican Mountain, Middle Wild Horse Mesa, Muddy Creek, Red's Canyon, San Rafael Reef, and Sid's Mountain





- The Secretary of the Interior shall appoint the members of each resource advisory council
- An individual many not serve concurrently on more than one resource advisory council

## Establishment of the San Rafael Swell Recreation Area Advisory Council

Council Members are distributed as follows

- 1. A representative of the Emery County Commission;
- 2. A representative of motorized recreational users;
- 3. A representative of non-motorized recreational users;
- 4. A representative of grazing allotment permittees within the Recreation Area or wilderness areas designated;
- 5. A representative of conservation organizations;
- 6. A representative with expertise in the historical uses of the Recreation Area; and
- 7. An elected leader of a federally recognized tribe that has significant cultural or historic connections to, and expertise in, the landscape, archeological sites, or cultural sites within the County.

  - Prepare and approve meeting agendas
  - Attend all Council meetings
  - Adjourn any meeting when the DFO determines to be in the public interest
  - Chair meetings when directed to do so by the Secretary

  - Participate in public discussion of issues during meetings
  - Provide notification when agenda items may be a potential conflict of interest

    - 4 out of 5






#### Special Recreation Permits



Parking issues and impacts from unprepared visitors.








### Access roads into the Swell Recreation Area that have trail counters











# What stayed the same in 2023? Spring and Fall peaks on Main Roads




### **Spring and Fall peaks on Trails**

#### Overview

The National Fish and Wildlife Foundation ("NFWF") requests Full Proposals under the Utah Lands with Wilderness Characteristics Fund ("Fund") for projects that will restore, reclaim, preserve,

conserve, and/or enhance wilderness characteristics in Utah. NFWF established and administers the Fund with monies it received as compensatory mitigation for authorized impacts of the Gateway South Transmission Project to Lands with Wilderness Characteristics ("LWC") in Utah, as approved by the Bureau of Land Management ("BLM") and its Record of Decision for the project.

NFWF, as the administrator of the Fund, will accept Full Proposals for projects through Thursday, March 16, 2023 at 9:59pm Mountain time. All proposed projects must provide adequate information in accordance with the evaluation criteria outlined below. Full Proposals will be reviewed and evaluated as described below. Funding awards will be made by NFWF to selected applicants for projects that best satisfy the evaluation criteria, as verified and approved by BLM. Thereafter, NFWF will execute project funding agreements with awardees that will implement the projects in accordance with the respective Full Proposals, applicable laws, and the terms and conditions of such project funding agreements, with monies provided from the Fund.

The requirements for responding to this Request for Proposals ("RFP") are described in the sections below. The process for responding to this RFP will be conducted using the NFWF Easygrants online application system as described in the How to Apply and Timeline sections at the end of this RFP.

#### **Geographic Focus**

The Fund will fund projects located in Utah, within lands determined by the BLM to possess wilderness characteristics (as further described below), or lands that are eligible for wilderness characteristics inventory. Such lands may include designated Wilderness areas, Wilderness Study Areas ("WSA"), and other lands managed to preserve wilderness characteristics. All project activities are to be located <u>either</u> on federal (public) lands within the following BLM administrative areas, listed here in descending order of priority: Vernal Field Office, Green River District, other BLM offices in Utah; <u>or</u> on non-federal lands adjacent to public lands identified as possessing wilderness characteristics. A map of these areas is shown here.

#### Funding Available


NFWF expects to award up to approximately \$3.2 million from the Fund to projects through this RFP. Up to approximately \$800,000 of this amount may be made available for public outreach, education, and interpretation projects.
