Meeting Minutes

Agenda Item: House Keeping, Introductions, and Opening Remarks

Facilitators: Elijah Waters, Greg Larson

Elijah Waters took over duties as the Designated Federal Officer and welcomed RAC attendees, facilitated introductions, provided an overview of the agenda, and discussed logistics and "housekeeping" items for the day. A quorum was present. Scott Braden was nominated and elected as the Chair. Katie Steele was elected as Vice-Chair.

Agenda Item: Review and Discuss the Natural Soda and Hunt Fire and Field Trip Facilitator: Elijah Waters

Elijah Waters and RAC members noted the high points of the Natural Soda facilities visit and Hunt Fire field trip.

Agenda Item: Fire Management Presentation and Discussion *"Fuels treatments, opportunities and challenges"*

Facilitators: Landon Smith and Lathan Johnson

Smith and Johnson presented an overview of Federal Fire Policy including fire management, risk management, fire science, working with other partners and planned versus unplanned fire. There was a discussion of fire in sage grouse habitat and controlled burns in sage grouse habitat. It was suggested to invite Kathy Griffin with Colorado Parks and Wildlife to further discuss at a future RAC meeting. The discussion also to provide RAC input on sage grouse EIS draft.

Agenda Item: Upper Colorado River Special Recreation Management Area - Business Plan Facilitators: John Monkouski, Stephen Leonard

John Monkouski summarized his June 2023 presentation from last NW RAC meeting, addressed fee changes to the plan based on RAC input from the June 2023 meeting, and answered questions before the motion to pass the Upper Colorado River Special Recreation Management Area Business Plan was unanimously approved.

Agenda Item: Field Manager Updates

Field Management and the RAC discussed current events in the field across the spectrum of land management programs. Success stories included restoration projects, wild horse management, business plan updates, facility improvements and collaborative efforts across the Northwest region. Agenda Item: Public Comment

There were no public comments at this RAC Meeting. Comments were received during this time from Hilary Henry of Senator Michael Bennet's Office. Henry said the Senator Bennet's office appreciates BLM engagement with his office and that Senator Bennet recently visited the Thompson Divide, Crested Butte and the Mid-Continent quarry site. Henry added that Senator Bennet is working on oil and gas bonding reform and is concerned about orphan wells. Henry said Senator Bennet has heard from wildland firefighters on wage issues and is in support of a permanent increase.

Agenda Item: Open Discussion

Tom Jankovsky commented on the previous wild horse resolution. It was suggested to create a common share location for the RAC to access previous resolutions, the website was suggested as the best location. John Justman suggested looking into a campaign to encourage better treatment of public lands and it was mentioned that a retired BLM employee is working on a no dumping campaign in the UCR. It was suggested to consider a combined NW and SW RAC to discuss the Dominquez-Escalante NCA.

Agenda Item: Closing Remarks

Elijah Waters thanked the group for their attendance and participation as a quorum was present. Waters and the RAC discussed possible future agenda items to include bringing in someone from Moab, UT to discuss recreation, a discussion on cheatgrass herbicide, fire ecology with Kathy Griffin, illegal dumping campaigns. Tours ideas included mitigation fund sites, the Blue Valley land exchange, American Gypsum, a bio-fuels plant tour and the North Park restoration projects.

The Chair thanked the White River Field Office for hosting and outgoing members for their service.
