## **Contract Report Data Dictionary**

ENTITY NAME	StratumData-C
DESCRIPTION	Report that pulls all unterminated timber sale contracts and those terminated contracts that have terminated during the current fiscal year. Content within the contract data includes contractor name, land status description, cutting method, etc.

REPORT LABEL	DESCRIPTION
Source System	The name of the Forest Resources Information System (FRIS) application.
State Office Code	The abbreviation of the BLM State Office that administers this contract.
Contract Identifier	The full alphanumerical code assigned to the contract.
District Code	The State abbreviation with numerical code assigned to a particular district in that State where that BLM State Office resides.
District Name	The name of the BLM District in the State.
Field Office Code	The State abbreviation with numerical code assigned to a particular office in that State.
Field Office Name	The name of the BLM Field Office.
Cur Purchaser	The name of the current organization/entity that has purchased in this contract.
City	The name of the city where the current purchaser is located.
State	The State abbreviation of the location of the current purchaser.
Zip	The zip code of the location of the current purchaser.
SBA Size	The size of the small business under the category of the Small Business Administration (if applicable).
Org Type	The form of business of the current purchaser.
Manufacturer	Identifies if the current purchaser is a manufacturer or not.
Last Assignment Date	The name of the city where the current purchaser is located.
Contract Name	The name assigned to the contract.
Sale Date	The date on which the contract was sold - high bidder identified at auction or negotiations completed.
Auction Format	The type of auction agreement used (e.g., Oral, Negotiated, Sealed, etc.).
Contract Mechanism	The document form number that is used for the contract.

Qualified Bidders	The number of bidders who qualified to bid on the contract.
Active Bidders	The number of bidders who actively participated in the auction.
Number of Bids	The total number of bids given by all active bidders.
Next High Bid	The dollar amount of the second highest bid.
Award Date	The date the contract was awarded to the high bidder. Same as sale date for negotiated contracts.
Contract Term	The number of months allowed for the harvest of timber.
Approval Date	The execution date the contract was given after final authorization from the BLM.
Original Expiration Date	The original date the contract was due to expire.
Current Expiration Date	The current date the contract is due to expire.
Acres Current	The total number of acres currently in the contract.
Mbf Current	The number of current MBF (1,000 board feet) of timber volume in the contract.
Ccf Current	The number of current CCF (100 cubic feet) of timber volume in the contract.
Gton Current	The number of current GTons (Green Tons) of biomass or other non-timber volume in the contract.
Value Current	The current dollar value of timber or other wood products.
Acres Uncut	The number of acres of uncut timber in the contract.
Mbf Uncut	The number of MBF of uncut timber in the contract.
Ccf Uncut	The number of CCF of uncut timber in the contract.
Gton Uncut	The number of GTons of uncut biomass or other non-timber volume in the contract.
Value Uncut	The dollar value of uncut timber or other wood products in the contract.
Acres Unyarded	The number of unyarded (current acres less yarded acres) acres of timber and other wood products.
Mbf Unyarded	The number of unyarded MBF of timber.
Ccf Unyarded	The number of unyarded CCF of timber.
Gton Unyarded	The number of unyarded Gtons of biomass or other non-timber volume.
Value Unyarded	The dollar value of the unyarded timber or other wood products.
First Install	The dollar amount of the first installment payment.  Note: This information is no longer reported as of 12/31/2018.

Payments Excl First	The dollar amount of all payments made except the first installment payment.  Note: This information is no longer reported as of 12/31/2018.
Unpaid Excl First	The dollar amount of total of unpaid except the first installment payment.  Note: This information is no longer reported as of 12/31/2018.
Unmatured Balance	The dollar amount that has not been paid on the contract that is not due.  Note: This information is no longer reported as of 12/31/2018.
Termination Date	The date the contract was terminated.
Termination Type	The type of reason the contract was terminated.
Cancel Reason	The specific reason the contract was terminated.
Load Date	The last date in which the data for the contract was last loaded/processed in the application.
Multi Agency	Identifies if this contract involves multiple agencies.
Lead Agency	The primary agency involving the contract.
Value Appraised	The appraised value of the contract.
Value Sold	The actual value of the timber or other wood products originally sold in the contract (excludes modifications).
Acres Offered	The total number of acres to be treated originally in this contract (excluding modifications).
