Transaction Report Data Dictionary

ENTITY NAME	StratumData-T	
DESCRIPTION	Report that pulls all cutting/activity reports entered within the current fiscal year and contains information about BLM harvest activity, such as current acres harvested, yarded, hauled, etc.	

REPORT LABEL	DESCRIPTION
Source System	The name of the Forest Resources Information System (FRIS) application.
Contract Identifier	The full alphanumerical code assigned to the contract.
State Office Code	The State abbreviation with numerical code assigned to a particular district in that State where that BLM State Office resides.
District Code	The State abbreviation with numerical code assigned to a particular district in that State.
District Name	The name of the BLM District in the State.
Observation Date	The date the harvest activity was observed in the field.
Observation FY	The fiscal year that the observation was completed.
Observation CY	The current calendar year that the observation was completed.
Unit Mod Type	Identifies if this activity is against an original cutting unit (U) or modification (M).
Land Base	The default land base for strata.
Land Status Code	The abbreviated form of the Land Status.
Land Status	Identifies the status type of the land.
Cut Method	Identifies the style of harvesting done.
Observation Month	The abbreviated month of when the last activity report was completed
County Code	The code given to the county starting with the abbreviated State name followed by its FIPS number.
County Name	The name of the county where the stratum exists.
Acres Cut	The total number of acres of timber cut for this stratum (note: a stratum is a subdivision of a cutting unit).
Acres Yarded	The number of yarded (volume removed from the contract area or at a designated landing) acres of stratum.
Value Cut	The dollar value of the cut timber in this stratum (This value is based on price-per-measure, is an approximation, and may differ from values derived from value per acre in the related total

	value cut for this cost structure on this contract)
Value Yarded	The dollar value of yarded timber in this stratum. (This value is based on price-per-measure, is an approximation, and may differ from values derived from value per acre in the related monetary value of acres yarded for the stratum).
Mbf Cut	The number of cut MBF (1,000 board feet) of timber in the stratum.
Mbf Yarded	The number of yarded MBF of timber in this stratum.
Ccf Cut	The number of cut CCF (100 cubic feet) of timber in this stratum.
Ccf Yarded	The number of yarded CCF of timber in this stratum.
Gton Cut	The number of cut GTons (Green Tons) of biomass or other non-wood volume in this stratum.
Gton Yarded	The number of yarded GTons of biomass or other non-wood volume in this stratum.
Load Date	The date this data was processed.
