

Outfitting Camp Hosts



Arctic Circle Campground Newly Renovated 2021

Amount Expended: \$5,913

BLM staff invested time to build amenities for camp hosts at the newly renovated Arctic Circle Campground. The campground located at the Arctic Circle is very remote—the closest grocery store is about 200 miles away. A 10' x 12' shed was constructed in the campground adjacent to the camp host site. The shed will allow camp hosts to store their dry goods and other supplies. Staff also constructed a non-potable water holding tank system to compensate for the lack of a well at the campground.

Public Use Cabin in Coldfoot

Amount Expended: \$1,359

The BLM operates several administrative cabins in the Coldfoot area which are used by staff for summer fieldwork. The cabins generally sit vacant during the winter. In fiscal year (FY) 2023, the Central Yukon Field Office updated its business plan to include the Coldfoot Cabin as a fee site. Beginning in the fall of 2024, the Coldfoot Cabin will be available to the public for wintertime rentals via Recreation.gov. The cabin is road-accessible and will cater to adventurous recreationists wishing to experience winter in the Arctic.
