A very wet Ivanpah Windsailing SRMA

Access the Ivanpah Windsailing SRMA is very challenging when annual rains occur. Rain on adjacent hills or over the site will quickly flood the northern access points before visitors on the southern end of lake are even aware flooding is occurring. Law Enforcement and Volunteers quickly respond to the area to warn visitors and move them safely out of the area before the soils become soft. Vehicle movement across the surface can create ruts and damage the smooth surface needed for wind sports. The Needles Field Office will require approximately \$100,000 to develop an all-weather road leading to the developed staging area.
