Mud Springs Campground Facelift

Amount Expended: \$900,000.00

The Mud Springs Campground received a \$900k full restoration in FY23 funded by GAOA dollars. Improvements to the entire site plan included all campsites, day use/picnic areas, bathrooms and water system were completed. ADA compliant campsites were also created. Since the campgound was closed all of FY23, minimal 1232 funds were expended.

18 Road Expansion

Amount Expended: \$156,704.00

In partnership with Mesa County and the City of Fruita, approximately 30 miles of new trails were laid out and contracted to be constructed starting in FY23 into FY24. Engineering site plans were developed to add 24 new campsites, two bathrooms and shade structures to the existing lower campground. Construction to take place summer of FY24. Capital construction costs were covered by a mix of grant dollars and state engineering funds. 1232 expenditures covered park ranger labor and materials.
