Amount Expended: \$48,697.41

During 2023, the BLM GFO used FLREA funds to hire one intern and 7 seasonal park rangers to support the recreation and visitor services program. Staff provided information to the public at the front desk for the Gunnison Field Office, maintained facilities and recreation amenities for the public, maintained trail networks, contacted visitors, and monitored recreation areas. In addition, FLREA funds supported law enforcement patrols and administrative functions to administer the fee program.

Amount Expended: \$4,995.00

The BLM GFO constructed and installed new kiosks at the Ten Mile Springs, Powderhorn Park, Devil's Creek, and Powderhorn Lakes trailheads. These kiosks provide wilderness visitors with important safety and leave no trace information about the Powderhorn Wilderness. These kiosks were installed by hand by Gunnison Field Office staff. The Powderhorn Wilderness is known for it's world-class big game hunting opportunities, and funding for the kiosk project was generated through guided hunting SRPs.

GFO will continue to utilize 1232 funds where they are generated. As visitor numbers and recreation demand continue to increase across the Gunnison Resource Area, locally generated revenues should continue to allow GFO to keep pace with demand; mainly through funding project supplies and supplementing the field-going recreation, law enforcement, and administrative workforce to support the fee program. GFO was successful in receiving external funds from CPW for motorized and non-motorized maintenance activities. GFO plans to roll over 1232 funds to supplement labor in FY25 and FY26: Goal \$75K. GFO will support two campground hosts, purchase signage & field supplies, and print brochures.
