Recreating in Bear Country

Amount Expended: \$1,950

Increased bear activity throughout the 2023 season, highlighted the need for improved messaging at recreation sites regarding wildlife safety. "Bear Aware" signs were designed and implemented in fiscal year (FY) 2024 to remind travelers of best practices while recreating in bear country; these were installed at campground entrances and other high traffic areas. Improvements to wildlife safety messaging will continue at campgrounds in FY2025.

Amount Expended: \$419

Each year thousands of visitors make the trek to the Arctic Circle Wayside, approximately 200 miles north of Fairbanks. While the Arctic Circle is just an imaginary line, for many visitors, stepping into the Arctic represents an important bucket list experience. Twenty-seven commercial operators under the Special Recreation Permit program offer tours to the Arctic Circle. CYFO staff spent 3 cold days monitoring visitation at the wayside during the winter solstice to greet visitors, hand out Arctic Circle certificates, and verify permit compliance.

- Per diem and expense reimbursement for Dalton Highway volunteers - \$27,500
- Coldfoot public use cabin retrofit - \$5,000
- Labor costs for recreation staff to service and upgrade fee sites - \$4,000
- Supplies needed for various interpretive programming and recreation sites - \$3,000
- Wildlife safety and awareness signage - \$2,500
