Amount Expended: \$79,500

BLM hired a contractor to paint the Piedras Blancas Light Station in preparation for the 150th anniversary of its original construction. The last time BLM painted the lighthouse was in 2011. BLM intends to paint the lighthouse on a 5-8 year rotation.

Amount Expended: \$9,717

The Case Mountain ERMA is a popular destination in the Three Rivers area managed by the Bakersfield Field Office. In 2024, Case Mountain had approximately 60,000 visitors participate in the many recreation opportunities provided including hiking, bicycle riding, hunting, fishing, and wildlife viewing. The BLM partnered with a local volunteer group to install 10 picnic tables located throughout the 20,000+ acre property.

- CXT solar vents and bathroom door installed at San Joaquin River Gorge - \$3,008.47
- Trash service in Keysville - \$22,000
- San Joaquin River Gorge, build ADA compliant ramp at end of outdoor deck at visitor center - \$15,000
