**Amount Expended: \$27,635.60**

Special Recreation Permits (SRP) are the largest source of income into the Ridgecrest Field Office's Recreation Fee Revenue program. Annually there are between 35 and 40 different SRPs conducted on the Public Lands within the Field Office. These SRPs include such activities as Equestrian Endurance Rides, Ultra Marathon running events, Four Wheel Drive outings, Dual Sport Motorcycle tours, Vending, Mountain Bike, Motorcycle, and Utility Terrain Vehicle (UTV) races.

The Fossil Falls Campground and Day Use area is a nice location for one to get away and enjoy the desert environment. Here one can find amenities including a hand pump for potable water, vault toilets, picnic tables and fire rings. Also, we have vault toilets at our most popular destinations including Trona Pinnacles National Natural Landmark, Spangler Hills, Jawbone Canyon, and Dove Springs Off-Highway Vehicle Recreation Areas. Funding was used to clean and maintain all these facilities.

Cost associated with the ongoing maintenance and upkeep of our 14 different vault toilet facilities located throughout our management area. (\$35,000)

In coordination with Naval Air Weapons Station China Lake purchase and install OHV Trail Crossing Signs along the Ransburg Wash Road within the Spangler Hills Off-Highway Vehicle Recreation Area. (\$8,000)
