#### Amount Expended: \$10,550.81

The Jupiter Inlet Lighthouse ONA is intensively visited with over 150,000 visitors a year and over 200 recreational, education, and interpretive programs. Keeping the visitor services and recreational infrastructure in excellent condition is a top priority. Fees collected through Special Recreation Permits support a range of recreational maintenance activities including the cleaning and maintenance contracts on the sites new restroom facilities.

#### **Amount Expended: \$39,697.49**

The BLM partners with the Loxahatchee River Historical Society to host community events at the Outstanding Natural Area (ONA) in support of the values for which the ONA was designated. The partnership utilizes fees collected through Special Recreation Permits to bring a wide variety of community educational and interpretive programs to the site from historical lectures, and marine educational courses to a once-a-year environmental film festival.

In 2025 the BLM plans to continue its partnership with the Loxahatchee River Historical Society, Florida Public Archaeology Network, and the Loxahatchee Environmental Control District to bring a wide range of educational and interpretive program offerings to the local communities served. Fees (\$15,000) will be used to support access (travel to site) for underserved communities and environmental justice populations along with covering program material costs and recreation infrastructure maintenance (\$10,000). Additional fees revenues (\$10,000) will be used to support local law enforcement agreements to ensure public safety and security on the public lands at the Jupiter Inlet Lighthouse ONA.
