Brownstone Canyon Boundary Fence

Amount Expended: \$5,000.00

Brownstone Canyon provides the public a unique wilderness experience and the chance to view one-of-a-kind pictographs. The wilderness boundary fence is often damaged by flash flooding or vandalism. To improve the visitor wilderness experience and prevent unauthorized vehicle entry into the wilderness, we placed (6) 55-gallon metal drums filled with concrete along the wash with a single strand of cable strung through to create a barrier. The barrels are painted tan to match the natural surroundings.

Amount Expended: \$20,000.00

Over 50 miles of mountain bike trails and 16 miles of dirt roads were formally designated and adopted into the BLM travel network after being analyzed for sustainability and utility within the larger recreation landscape. These recreation resources are open to mountain bikes, hikers, electric mountain bikes, equestrians, and OHV. Completing the recreation area management plan took over two years and was made possible by the Friends of Red Rock Canyon securing a grant to cover the cost of the environmental assessment. The BLM provided \$20,000 of in-kind
