BLM recreation sites in the Yakima River Canyon have had a long history, from poorly maintained river access sites and rowdy customers to the well maintained and family friendly developed recreation sites they are today. Much of this is thanks to BLM Park Rangers. They are the unsung heroes of the Yakima River Canyon, providing the first line of customer service, maintenance and fee administration. Wenatchee Field Office uses fee dollars to partially fund two seasonal park rangers to provide seven-day-a-week coverage.
