

Moquith WSA Fence Rebuild



KFO interns building new fence sections

Amount Expended: \$36,351.70

Repair of the Moquith Mountain Wilderness Study Area boundary fence within the BLM Kanab Field Office was initiated in Fiscal Year 2024. The fence helps to prevent vehicular incursions into the WSA and to limit impacts to T&E plant species (e.g., milkweed) present in the sand dunes (also in the WSA). The fence line is in poor/deteriorating condition, and recent trends of increasing visitor use in the area necessitate that the fence needs repaired. The completed project will replace approximately 33,658 feet (6.4 miles) of WSA boundary fencing.

Amount Expended: \$4,000.00

Off highway vehicle use impacts to Welsh's Milkweed habitat were addressed during Fiscal Year 2024 through the placement of route delineators and barricades to encourage visitors to stay on designated routes.

- *Complete Peek-a-Boo OHV TH expansion project.
- *Installation of off-grid electronic-pay stations: Wire Pass and Buckskin trailheads.
- *Administered Coyote Buttes North volunteer safety program.
- *Operations and maintenance of the Paria Contact Station.
- *Installation of new vault toilets at Sand Caves, and Belly of the Dragon.
- *Administration of the KFO SRP program.
- *Operations and maintenance of the Ponderosa Campground and Kanab Field office trailheads.
