

Big Bend Campground Improvements



Additional Campsites Constructed at Big Bend

Amount Expended: \$70,000.00

During previous busy spring and fall seasons, this area was used as overflow when all the campsites were full. There are now eleven new campsites with picnic tables, fire rings and site posts. A day use parking area was also created. Two new steel gates were installed in the main campground to prevent campers from driving through a low water crossing area during floods and a turnaround area was created on each side.

Courthouse Rock Improvements



Two New Shade Shelters at Courthouse Rock

Amount Expended: \$50,000.00

The Maintenance Crew fabricated and installed two 20' x 20' steel shade shelters for two reservable equestrian campsites in the Courthouse Rock Campground. This campground is located along the Old Spanish National Historic Trail and is home to commemorative silhouettes. The ability to reserve these campsites and two horse corrals, make this area popular with equestrians. The area is also a favorite for motorized enthusiasts. The adjacent Mill Canyon day use site is popular with campers, recreationists and permittees as it features an elevated boardwalk over dinosaur tracks.

Other Accomplishments

- Constructed a new reservable group site at Lower Onion Creek. Installed new toilets at Fisher Towers, Bitter Creek, Fish Ford, Rock Castle and Falcon trailhead. Extensive weeding and vegetation control in these campgrounds.
- Repaired damage caused by flood and wind events. Replaced site posts, repaired tent pads, improved drainage, and repaired access roads.
 Worked with volunteers to improve campgrounds by weeding and staining group shelters.
- Installed new steel kiosks at Goose Island, Grandstaff, Big Bend, Upper Big Bend and Horsethief campgrounds, Fisher Towers, Hidden Valley and Professor Creek trailheads. Purchased remote payment station for Goose Island CG.

New toilet for the Big Bend Campground

*Install CXT toilet to improve safety at Big Bend: \$60,000. *Replace six existing concrete toilets that are from 1990s and in disrepair: \$200,000. *Improvements to Kokopelli campgrounds. Clean toilets and fire rings in 700+ campsites and 39 reservable group sites: \$250,000. *Toilet pumping and dumpsters: \$250,000. *Annual filling of potholes at entry to campgrounds and trailheads: \$20,000. *Transition Moonflower to a reservable day use site: \$10,000. *Fencing of Fish Ford Campground with fuels program: \$20,000. *Install new ROK at North Klondike Campground: \$20,000. *Delineate campsites for the new Mud Springs trail system: \$50,000. *Delineate campsites for the new Mud Springs trail system: \$50,000.
