OHV Trail Maintenance



Trail Maintenance in the San Rafael Swell

Amount Expended: \$42,831

In FY 2024, the BLM dedicated 309 hours of OHV trail maintenance, with Emery County to maintain approximately 45 miles of trail. These efforts would not have been possible without the support of Emery County and other partners. These joint efforts enhance trail safety, ensure route connectivity, and improve the visitor experience. Recreation fees provided \$19,892 in staff labor, and \$22,939 was leveraged to purchase a new equipment trailer to support these projects.

Green River Resource Trips



River Recreation Trail Improvement Project

Amount Expended: \$16,972

The river program, supported by recreation fees, organized 4 resource monitoring trips on the Green River with 7 BLM staff, 9 members from various organizations, and 8 volunteers. These trips focused on monitoring recreation, wilderness, biological, and cultural resources. Recreation focused efforts included removing hundreds of pounds of trash from the river corridor, reestablishing a trail in Range Creek to mitigate resource damage post wildfire, and treating invasive plants and noxious weeds.

Other Accomplishments

- Recreation fees supported campground upgrades at the Price Canyon Recreation Area, including new accessible fire rings, vegetation removal, and picnic table repairs.
- Recreation fees funded a Utah Conservation Corps Crew to reconstruct a portion of the Bristlecone Nature Trail after a recent fire.
- Recreation fees funded a Utah Conservation Corps intern who performed 480 hours of trail and campground maintenance.
- River rangers hosted a Green River Daily cleanup day, with the River Runner's Hall of Fame, contributing 30 volunteer hours.

Price Canyon Recreation Area Improvements

- Purchase and install barricade and delineation boulders, \$10,000.
- Purchase and install campsite and access road maintenance materials (gravel and culverts), \$10,000.
- Support toilet pumping contract (47 vaults), \$32,000.
- Support garbage collection at Swasey's Beach, \$24,000.
- Purchase potable water delivered to Sand Wash, \$10,000.
- Purchase rafts for the river program, \$20,000
- Complete renovations at Price Canyon Recreation Area, \$10,000.
