#### Wyoming Wind Damage

**Amount Expended: \$1,000.00**

In Wyoming we do not say the word “wind” on a day that the wind is not blowing. Some people prefer to say something like “air movement” instead because it seems to start blowing as soon as the “W” word is used. Wind in Wyoming can blow hard enough to peel back roof material which happened at the Fee site named Fontenelle campground. A concerned citizen called in to the Kemmerer Field Office and reported damage being done on two roofs due to the wind. One roof was a warehouse building and the other was a restroom building. Items were purchased and the roofs were repaired.

**Amount Expended: \$100.00**

A concerned citizen saw cows and horses in the Fontenelle campground and called in to report a wounded horse. The cattle and horses were removed from the campground, gates that had been left open were closed and some fence was repaired. A BLM Law Enforcement officer was approached by a camper that who was staying at the Weeping Rock campground and reported cattle in the campground rubbing against their camper trailer. The cattle were removed a cattle guard was repaired and a top rail on a on a log fence was replaced.
