#### Sign Repair and Replacement

**Amount Expended: \$16,000.00**

During 2024 the Ely District worked on keeping our BLM signs in order. This include installing a new "Welcome to the Ely District" portal sign on the Nevada-Utah Border, installing Backcountry Byway signs, and adding many general wayfinding signs out on Public Land to help visitors navigate our wide-open remote landscape. Over 45 signs were inspected, 30 were repaired, 18 were replaced and 17 new signs were installed.

Weeds at Recreation Sites

**Amount Expended: \$15,000.00**

During 2024, the Ely District entered into an agreement with Tri-County Weed Control for the purpose of treatment of 15 developed recreation sites on an annual basis. The scale of weed infestations at each of these recreation sites has surpassed what is reasonable for our support services to be able to maintain. We use Tri-County Weed Control for many other projects and areas on our District and have always had great success. With this season being the first treatment, next year and subsequent years shall yield weed free recreation sites.

Trilobite Site: \$5,000 - Purchase and install gravel for the parking lot. Re-do the walking path from the parking lot to the site and install wayfinding signage around site. Install new picnic table.

Meadow Valley Campground: \$5,000 - Purchase gravel for the camping spots. Trim back overgrown branches that are in the camp site and the walking path. Re-work the walking path from the bathroom.

Ward Mountain Recreation Area North TH: \$5,000 - Limbing, tree removal and trail maintenance on 4 miles of the Birkebeiner trail which will improve winter and summer recreation sports.
