**Amount Expended: \$75,000.00**

BLM completed the Logandale Trails RMP amendment that designated the Logandale Trails area as a Special Recreation Management Area (SRMA), created a Recreation Area Management Plan, and completed a Travel Management Plan (TMP). The final FONSI and Decision Record were signed on Feb. 15, 2024. LVFO also continued to work on a TMP for the Muddy Mt. SRMA and has completed the route inventory, route evaluation, prepared the draft EA and TMP, and held a public comment period to review the draft documents.

The site has information about Recreation in Southern Nevada, Safety, Camping, Target Shooting, Off-Highway Vehicle, and Dumping information.
