Summary of Changes between the 2012 and 2025 National Programmatic Agreement

Preamble

The Preamble has been reduced to only whereas clauses and has simplified/reduced much of the 2012 text. In doing so, some of what would be considered background information has been removed or simplified. A lot of this restated our requirements under NHPA and other laws. References to requirements under other laws have mostly been removed.

Stipulations

"Components" have been changed to "stipulations," which is more appropriate for a PA. Stipulations have been reorganized from the 2012 version.
