### FIRE PREVENTION ORDER# AZ-100-25-01 **STAGE 1 FIRE RESTRICTIONS DUE TO HIGH FIRE DANGER** BUREAU OF LAND MANAGEMENT, ARIZONA STRIP DISTRICT

Pursuant to 43 Code of Federal Regulations (CFR) 9212.2, the following acts are prohibited on all lands administered by the Bureau of Land Management in the following counties: Mohave and Coconino, Arizona. This restriction includes the Arizona Strip District encompassing Arizona Strip Field Office, Vermilion Cliffs National Monument, and the Grand Canyon-Parashant National Monument.

These restrictions will become effective at 12:01a.m., MST, 1 June 2025. They will remain in effect until rescinded or revoked.

**Stage 1 Restrictions:** The following acts are prohibited on BLM managed lands until further notice.

1. Building, maintaining, attending, or using a fire, campfire, charcoal, coal, or wood stove. Campfires and charcoal use are permitted in developed recreation sites or improved sites where agency-built fire rings or grills are provided.
2. Smoking, except within an enclosed vehicle or a developed or improved recreation site or while stopped in an area at least six feet in diameter that is barren or cleared of all flammable materials.
3. Welding or the use of any torch or metal cutting or grinding implement.
4. Discharging a firearm except while engaged in a lawful hunt pursuant to state, federal, or tribal laws and regulations.

Fire Prevention Order Number AZ910-2024-001 (partial description): Fireworks, airborne luminaries, tracers, explosives, steel core, incendiary ammunition and explosive chemical devices or binary explosives, incendiary bomb, grenade, or similar device. Any combustible or explosive composition. Igniting of tires, petroleum products are prohibited year-round and apply to all BLM managed lands within Arizona.

#### **Stage 1 Exemptions:**

1. Persons with a written permit that specifically authorizes the otherwise prohibited act.
2. Persons using a device solely fueled by liquid petroleum or LPG fuels that can be turned on and off. Such devices can only be used in an area that is barren or cleared of all overhead and surrounding flammable materials within six feet of the device.
3. Persons conducting activities in those designated areas where the activity is specifically authorized by written posted notice.
4. Any Federal, State, or local officer or member of an organized rescue or firefighting force in the performance of an official duty.
5. Other exemptions unique to each agency/tribe.

Violation of this order is prohibited by the provisions of the regulations cited. "Any person who knowingly and willfully violates the regulations at 43 C.F.R. § 9212.1 shall, upon conviction, be subject to a fine of not more than \$1,000 or imprisonment of not more than 12 months, or both, in accordance with § 9212.4. In addition, such persons will be liable to the United States for damages through either an administrative process or in United States Federal court."
