Dear Mr. Bisson:

Pursuant to 43 CFR §1864, the State of Alaska files this application for a recordable disclaimer of interest for the lands underlying the Tanana River.

I. DESCRIPTION OF WATERWAY

This application is submitted for all submerged lands lying within the bed of the Tanana River between the ordinary high water lines of the left and right banks from its origin at the confluence of the Chisana and Nabesna Rivers within Section 29 and 30, Township 15 North, Range 19 East, Copper River Meridian, Alaska flowing generally northwesterly to all points of confluence with the Yukon River in Section 23, Township 4 North, Range 22 West, Fairbanks Meridian, Alaska. As a general rule, any sloughs, braids or channels that carry water from a navigable river are an integral part of the river and thus, are navigable as well.

A map highlighting the river and a legal description of the townships and ranges underlying the river are enclosed.

II. WAIVER REQUEST

As previously discussed with the Bureau of Land Management Alaska State Director, the State requests a waiver under §1864.1-2(d) of the requirement of 43 CFR §1864.1-(c) (1) for the description based on a public land survey or certified metes and bounds survey because the map and legal description included here clearly identify the land subject to this application.

III. Basis for the State's Request for a Recordable Disclaimer of Interest

Navigability of the waterway - The State's application for a Recordable Disclaimer of Interest is based on the Equal Footing Doctrine; the Submerged Land Act of May 22, 1953; the Alaska Statehood Act; the Submerged Lands Act of 1988; or any other legally cognizable reason. The Bureau may disclaim interest in the submerged lands on any of the grounds that apply.

Because the Tanana River is navigable, Alaska owns the submerged lands by virtue of the Equal Footing Doctrine. Under the Equal Footing Doctrine, new states created from federal territories are admitted to the Union with all the powers of sovereignty and jurisdiction that pertain to the original states. Upon admission of a State to the Union, the title to lands underlying navigable waters within its boundaries automatically passes to the State as a matter of constitutional grace.

The State as the upland owner - Generally, where the State is the owner of the uplands adjacent to Tanana River, the State owns the bed of the Tanana River even in the absence of a navigability determination. In such circumstance, the State took title under the Equal Footing Doctrine if the water is navigable, or if it is non-navigable the State gained title as a result of the intent of the grantor and state law governing riparian rights. In Alaska, where the land bordering the non-navigable body of water is ceded, title to the submerged land passes to the shore land owner unless the intent of the grantor is expressly stated to the contrary.

IV. REASON FOR THE STATE'S REQUEST FOR RECORDABLE DISCLAIMER OF INTEREST

The lack of any title document or judgment creates a cloud on the State's title. A recordable disclaimer for this land will help lift the cloud on its title stemming from the lack of any permanent determination of ownership.

V. EVIDENCE OF THE NAVIGABILITY OF THE TANANA RIVER

The Bureau's own formal determinations confirm navigability of the Tanana River. Navigability determinations for all, or portions, of the Tanana River are available from May 13, 1974 through February 15, 2005. A summary of those determinations, decision documents and copies are attached to this application.

Historic information on boat use on the Tanana River adds to this navigability determination. The Tanana River has a long history of commercial navigation and was used extensively as a service route for freighting supplies to prospectors for early mining exploration, trading with Native villages, large and small steamboat traffic, barge lines and, more recently, a tourist sternwheeler. Information describing historic and current boat use on the Tanana has been

recorded in numerous documents, reports and books since the early 1800's. A summary of historic information describing navigability of the Tanana River is presented in a bibliography prepared by the Arctic Environmental Information and Data Center and is attached to this application. A listing of additional navigability documentation is included.

VI. OTHER KNOWN INTERESTED PARTIES

The State is not aware of any adverse claimant or occupant of these lands.

VII. CONCLUSION

As evidenced by navigability determinations and historic information, the State of Alaska determines that there is sufficient information to conclude that the Tanana River is a navigable waterway and ownership of its' submerged lands should be disclaimed by the Department of Interior.
