MINUTES

Designated Federal Officer (DFO) Update: DFO provided update and insight into BLM-Idaho leadership staffing, Administration's EO/SO-energy, geothermal/renewable energy, hydrogen exploration, minerals, mines/phosphate, timber program, EXPLORE Act, recreation, America 250, permitting, and NEPA programs.

Fire Season Update: As of 12 August 2025, the Great Basin region has had 688 fires which have burned 124927 acres

Proposed Recreation Fee Increases, Developed Sites: Challis Field Office: Proposed increase/adjustment in fees for 4 existing campgrounds, establish new fee for 3 campgrounds. Reservations system and First Come/First Serve (FCFS)

Proposed Recreation Fee Increases, Developed Sites: Proposed Sites: Proposed

Proposed Recreation Fee Increases, Developed Sites: Upper Snake Field Office: Proposed fee increase for 2 campgrounds and 1 amenity site

Proposed Recreation Fee Increases, Individual Special Recreation Permits: Upper Snake Field Office: Proposed Special Permit Fee structure of dispersed camping sites along the upper Snake River

Proposed Recreation Fee Increases, Developed Sites: Payette River Sites (USFS & BLM-FRFO):

Proposed fee increase for several developed recreation sites and new fees for several sites still to be developed, for a total of 64 sites, 4 BLM sites which are maintained by USFS during the fee collection season. Vote was taken for ALL business plans to adopt the fee structure and reservation system as proposed by field offices and Boise National Forest to the appropriate governing bodies. Motion to Approve Recommendation of Fee Proposals was made by Don Hall and 2nd by John Robison; the vote passed unanimously.

ACTION ITEM: Recreation Fee Proposal Recommendation to the Boise National Forest to be sent to the Boise National Forest, NLT 01 October 2025.

Changes to DOI NEPA Process: Presentation on the 2025 changes to National Environmental Policy Act law, regulations and policy. The presentation focused on the rescission of CEQ regulations and changes related to categorical exclusions, public involvement, and pre-NEPA requirements.

BLM Idaho Geothermal Program and Upcoming Lease Sales: Presentation of the Geothermal Program and approaching Lease Sales within BLM-Idaho.

Public Comment Period: Email comment on Federal register, Dan Sakura, Karen Steenhof, Shaua Robinson, Alex Ernst had public comments.

District Updates: Each district provided updates and status of projects supporting the Administrations Executive Actions & Secretarial Orders.

Status of Nominations: Nominations of persons to be members of the Idaho Resource Advisory Council are on hold until further notice.

FY 2026 Scheduling: Until further notice, all meetings, when a quorum is reestablished, will be virtual meetings.
