NATIONAL WILD HORSE AND BURRO ADVISORY BOARD

RENEWAL CHARTER

- 1. ADVISORY COMMITTEE'S OFFICIAL DESIGNATION:** Wild Horse and Burro Advisory Board (Board).
- 2. AUTHORITY:** The Board is established pursuant to section 7 of the Wild Free-Roaming Horses and Burros Act (Act) (16 U.S.C. § 1337) and is operated pursuant to the Federal Advisory Committee Act (FACA), as amended (5 U.S.C. Ch. 10) and the Federal Advisory Committee Management regulations found at 41 C.F.R. 102-3. In addition, the Bureau of Land Management (BLM) is subject to additional standards and procedures for the creation, operation, and termination of BLM advisory committees found at 43 C.F.R subpart 1784.
- 3. OBJECTIVES AND SCOPE OF ACTIVITIES:** The Board will provide advice to the Secretary of the Interior and to the Secretary of Agriculture on wild horse and burro policy formulation and oversight of the Wild Horse and Burro Program (Program) administered under the provisions of the Act. The Board will communicate its advice through the Designated Federal Officer (DFO) to the Director of the Bureau of Land Management (BLM) and the Chief of the Forest Service (FS), who will then communicate the Board's advice to the Secretaries of Interior and Agriculture (Secretaries), respectively.
- 4. DESCRIPTION OF DUTIES:** At the request of the Director of the BLM, and in an advisory capacity only, the Board will gather to analyze information and consider public comments on matters relating to the respective agencies' powers and duties under the Act. Those responsibilities include the protection and management of wild free-roaming horses and burros as components of the public lands; designation and maintenance of specific ranges on public lands as sanctuaries for their protection and preservation (where appropriate); and management at the minimal feasible level to protect natural ecological balance of all wildlife species which inhabit such lands, particularly endangered wildlife species; and to ensure forage allocations on such lands take into consideration the needs of permitted livestock and other wildlife species that inhabit such lands.

Specifically, the Board may be directed to:

- a. Review current and proposed management practices on the protection and management of wild horses and burros;
- b. Review the disposition and humane handling of wild horses and burros and recommend appropriate changes that will facilitate these actions;

- c. Review current management actions and advise BLM and FS as to whether they are effective for agency goals;
- d. Advise BLM and FS on ways to stimulate public and private participation to facilitate adoptions and sales;
- e. Advise BLM and FS on ways to foster cooperation and provide liaison among Federal, State, Tribal, and local governments; private organizations and affected interests; humane groups; the scientific community; and others;
- f. Advise BLM and FS in assessing the scientific basis for managing populations of wild horses and burros; and
- g. Compile a written report to the Secretaries of the Interior and Agriculture highlighting the results of its deliberations and make recommendations concerning major management practices as requested by the Director of BLM and the Chief of the FS.

All current and future Executive Orders, Secretary's Orders, and Secretarial memos should be included for discussion and recommendations, where applicable, as they are released.

- 5. **AGENCY OR FEDERAL OFFICER RECEIVING THE BOARD'S ADVICE/ RECOMMENDATIONS:** The Board reports to the Secretary of the Interior, through the Director of BLM, and the Secretary of Agriculture, through the Chief of the FS.
- 6. **SUPPORT:** Administrative support for activities of the Board will be provided by BLM.
- 7. **ESTIMATED ANNUAL OPERATING COSTS AND STAFF YEARS:** The annual operating costs associated with supporting the Board's activities are estimated to be \$55,000, including all direct and indirect expenses and 0.2 Federal staff years support. Estimated payments to Federal Staff: \$35,500; publication of Federal Register notices: \$500; facilitation services: \$18,500; and printing and shipping: \$500.
- 8. **DESIGNATED FEDERAL OFFICER:** The DFO is BLM's Assistant Director for Resources and Planning, who is a full-time Federal employee appointed in accordance with Agency procedures. The DFO must:
 - a. Ensure their Board activities comply with the FACA, FACA Final Rule, Agency administrative procedures, and any other applicable laws and regulations;
 - b. Approve or call all meetings of the Board or subcommittee;
 - c. Approve the agenda;
 - d. Attend all Board and subcommittee meetings for their duration;
 - e. Fulfill the requirements under section 1009 of the FACA;

- f. Adjourn any meeting when the DFO determines it to be in the public interest;
- g. Chair any meeting when so directed by the Secretaries;
- h. Maintain information on Board activities and provide such information to the public, as applicable; and
- i. Ensure Board members and subcommittee members, as applicable, receive the appropriate training (e.g., FACA overview, ethics training) for efficient operation and compliance with FACA and FACA Final Rule.

In addition, the DFO should ensure a public-facing website is created and maintained for the Board.

- 9. **ESTIMATED NUMBER AND FREQUENCY OF MEETINGS:** The Board will meet at least once annually, and at such other times as designated by the DFO.
- 10. **DURATION:** The duration of the Board is continuing, subject to the Termination section below.
- 11. **TERMINATION:** The Board will become inactive 2 years from the date the charter is filed, unless, prior to that date, it is renewed in accordance with the provisions of section 1013 of FACA. The Board will not meet or take any action without a valid current charter.
- 12. **MEMBERSHIP AND DESIGNATION:** Members will be appointed and serve at the pleasure of the Secretaries of the Interior and Agriculture. Members will be appointed as representatives or special Government employees from the following organizations or categories:
 - a. Wild horse and burro advocacy groups;
 - b. Wild horse and burro research institutions (especially genetics, population biology, and equine behavior);
 - c. Veterinary medicine (equine science);
 - d. Natural resources management organizations (especially rangeland science);
 - e. Humane advocacy groups;
 - f. Wildlife management organizations;
 - g. Livestock management organizations;
 - h. General public (with special knowledge about equine behavior); or

- i. General public (with special knowledge about protection of wild horses and burros, management of wildlife, animal husbandry, or natural resource management).

The Board will have no more than nine members, and members may not be employees of the Federal or State Governments.

Members will be appointed to the Board to serve 3-year terms.

A quorum is achieved when six members are present.

13. ETHICS RESPONSIBILITIES OF MEMBERS:

Special Government Employee Members. Members of the Board appointed as special Government employees (SGE) are subject to applicable Federal ethics statutes and regulations, to include applicable exceptions and exemptions. Additionally, SGE members are required, prior to appointment and annually thereafter, to file a Confidential Financial Disclosure Report. SGE members are also required to receive initial ethics training prior to performing any Board duties and to receive annual ethics training thereafter. The Department of the Interior will provide materials to those members serving as SGEs, explaining their ethical obligations.


Non-Federal Members Who Are Not Special Government Employees. Non-Federal members of the Board and subcommittees are appointed as representatives and therefore are not subject to Federal ethics statutes and regulations. However, non-Federal Board and subcommittee members may not participate in any Board and subcommittee deliberations or votes relating to a specific party matter before the Department or its bureaus and offices including a lease, license, permit, contract, grant, claim, agreement, or litigation in which the member or the entity the member represents has a direct financial interest.

Members of the Board shall be required to disclose to the DFO their direct or indirect interest in leases, licenses, permits, contracts, or claims, grants, or any specific party matter that involves lands or resources administered by BLM or FS, or any litigation related to those matters. For the purposes of this paragraph, indirect interests include holdings of a spouse, minor child, immediate family member, relatives, business partners, or employers that would benefit financially from the Board's recommendations. The DFO must report any required disclosures under this paragraph to the BLM Deputy Ethics Counselor, who will coordinate with the Departments of the Interior or Agriculture Ethics Office as appropriate.

14. **SUBCOMMITTEES:** Subject to the DFO's approval, subcommittees can be formed for the purposes of compiling information or conducting research. However, such subcommittees must act only under the direction of the DFO and must report their recommendations to the full Board for consideration. Subcommittees must not provide advice or work products directly to the Agencies. Subcommittees will meet as necessary to accomplish their assignments, subject to the approval of the DFO and the availability of resources.

15. **RECORDKEEPING:** Detailed records must be kept of each Board and formally or informally established Board subcommittee meeting. All records must be made available to the public, subject to the Freedom of Information Act (5 U.S.C. § 552), and must be handled in accordance with General Records Schedule 6.2 and other approved Agency records disposition schedules.
