NOTICE IS HEREBY GIVEN that the Wyoming Bureau of Land Management will offer for sale Sawtimber and Product other than Log (POL) as described herein. This is a sale notice only and does not contain contract provisions, prospectus, or exhibits. Items listed below are a summary only of certain contract provisions and do not contain the exact wording as shown in the contract. A copy of the timber sale contract, along with all exhibits, are available for inspection at the above office or by email. All bidders should inspect these documents prior to bidding on this sale.

A Determination of NEPA Adequacy (DOI-BLM-WY-P060-2018-0164-DNA) and Decision Record were prepared for this sale. These documents are available for inspection as background for this sale at the Casper Field Office.

The Bureau of Land Management will offer sawlogs and POL for sale as described below. The right is hereby reserved to waive technical defects in this supplement.

Note: This is a sealed-bid scale sale.

DATE, PLACE, AND TYPE OF SALE: Sealed bids will be received by the Casper Field Office Manager, or their representative, at 2987 Prospector Drive Casper, Wyoming 82604. Sealed bids must be received by 2:00 pm on August 13th, 2026.

A WRITTEN BID on Form 5440-9 shall be required to participate in sealed bidding. A required Bid Deposit of \$1,000.00 shall be made in the form of cash, money order or bank draft, cashier's or certified check (made payable to the U.S. Department of Interior – BLM), bid bonds of corporate surety shown on the approved list of the U.S. Treasury Department, or an irrevocable letter of credit. Personal checks will not be accepted.

PRE-AWARD QUALIFICATIONS. The high bidder may be required to furnish information to determine the ability to perform the obligations of the contract. If the high bidder is determined not qualified, responsible or refuses to respond within fifteen (15) days of a request for information pertaining to qualifications, the contract may be offered and awarded for the amount of the high bid to the highest of the bidders who is qualified, responsible, and willing to accept the contract.

THE SUCCESSFUL BIDDER, as a condition of award, will be required to complete and/or sign the following forms:

1. Form 5430-11, Independent Price Determination Certificate, certifying that the bid was arrived at by the bidder or offeror independently and was tendered without collusion with

any other bidder or offeror.

2. Form 5460-15, Log Scale and Disposition of Timber Removed Report

PERFORMANCE BOND: Prior to award of the contract to the high responsive bidder, a performance bond in an amount not less than twenty (20) percent of the total purchase price at a minimum amount of \$2,000 will be required.

INSTALLMENT PAYMENTS may be authorized for this sale. Required installments will be determined by BLM and will not be less than 10% of the total purchase price. See Section 3 of the contract regarding other methods of payment.
