

DISCLAIMER OF INTEREST

WHEREAS an application has been filed with the United States to disclaim any interest which the United States might have in the property described below; and

WHEREAS the official land title records of the United States disclose that the United States has no interest in the property described below;

NOW THEREFORE, the United States, pursuant to the Federal Land Policy and Management Act of October 21, 1976, section 315, 43 U.S.C. 1745 does hereby disclaim any interest in the following described property, to wit:

Goodnews River, including Goodnews Lake: All eligible submerged lands between the ordinary high water of the left and right banks of the Goodnews River and between the ordinary high water lines of Goodnews Lake, from the confluence with the Igmiunanik River near river mile 69 in sec. 35, T. 7 S., R. 66 W., Seward Meridian, Alaska, downstream through sec. 19, T. 10 S., R. 70 W., Seward Meridian, Alaska.

South Fork Goodnews River: All eligible submerged lands between the ordinary high water of the left and right banks of the South Fork Goodnews River from the confluence with an unnamed creek near river mile 25.7 in sec. 3, T. 12 S., R. 70 W., Seward Meridian, Alaska, downstream through sec. 22, T. 12 S., R. 72 W., Seward Meridian, Alaska.

Tivyagak Creek: All eligible submerged lands between the ordinary high water of the left and right banks of Tivyagak Creek from the confluence with an unnamed creek near river mile 8.25 in sec. 28, T. 12 S., R. 71 W., Seward Meridian, Alaska, downstream to its confluence with the South Fork Goodnews River in sec. 7, T. 12 S., R. 71 W., Seward Meridian, Alaska.

Middle Fork Goodnews River, including Middle Fork Lake: All eligible submerged lands between the ordinary high water lines of Middle Fork Lake and between the ordinary high water of the left and right banks of the Middle Fork Goodnews River, from the inlet to Middle Fork Lake in sec. 10, T. 9 S., R. 67 W., Seward Meridian, Alaska, downstream through sec. 18, T. 11 S., R. 70 W., Seward Meridian, Alaska.

Kukaktlik River, including Kukaktlim Lake: All eligible submerged lands within the ordinary high water lines of Kukaktlim Lake and between the ordinary high water of the left and right banks of the Kukaktlik River, from the inlet to Kukaktlim Lake in sec. 36,

T. 9 S., R. 67 W., Seward Meridian, Alaska, downstream to its confluence with the Middle Fork Goodnews River in sec. 23, T. 10 S., R. 69 W., Seward Meridian, Alaska. The aforesaid portions of the Delta River and the Tangle River, including the interconnected Tangle Lakes may be located within other sections and townships due to the ambulatory nature of waterbodies.
